A BILL FOR AN ACT

RELATING TO HEALTH INSURANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. (a) There is established in the department of health for administrative purposes a temporary autism disorders 2 3 spectrum benefits and coverage task force. The children with 4 special health needs branch shall be responsible for 5 administering the work of the temporary task force, providing a 6 facilitator, and submitting a report to the legislature. goals of the temporary task force shall be to discuss and seek 7 8 input on the problems faced by parents of children with autism 9 and what can be done to ensure that proper health benefits and 10 services are provided through public and private resources to 11 address the special needs of children with autism, including 12 providing services involving applied behavioral analyses techniques. In addition, the task force shall research health 13 14 insurance coverage plans that cover autism spectrum disorders in 15 other states and develop a plan of services that health insurers

should be mandated to cover.

16		Service Association or the chief executive officer's
17		designee; and
18	(8)	Two parents of children diagnosed with autistic
19		spectrum disorder appointed by the governor.

21	coverage	task force shall submit a report of its findings and
