A BILL FOR AN ACT

RELATING TO FEES FOR WINDSHIELD PLACARDS FOR PERSONS WITH
DISABILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 291-51.3, Hawaii Revised Statutes, is
2 amended to read as follows:

3 "[~~+~~]**\$291-51.3**[+] **Reimbursement to counties.** The State
4 shall reimburse the counties for the unit cost of issuing a
5 removable windshield placard or a temporary removable windshield
6 placard on behalf of the State. Beginning July 1, 2006, the
7 rate of the per unit cost reimbursement shall be \$12. All fees
8 collected by the counties for issuing removable and temporary
9 removable windshield placards shall be deposited into the
10 general fund."

11 SECTION 2. Section 291-51.6, Hawaii Revised Statutes, is
12 amended to read as follows:

13 "**\$291-51.6 Issuance of temporary removable windshield**
14 **[parking] placards.** Each county shall issue one temporary
15 removable windshield placard and a second temporary removable
16 windshield placard to each applicant who requests and presents a
17 certificate of disability that verifies the duration of the



1 applicant's disability in monthly increments, which shall not
2 exceed six months, and upon payment of a fee to the issuing
3 agency. All fees collected by the counties for issuing
4 temporary removable windshield placards shall be deposited into
5 the general fund. The temporary removable windshield placard
6 shall be designed, fabricated, and sold to the counties at a
7 rate negotiated by the disability and communication access
8 board."

9 SECTION 3. Section 291-52.6, Hawaii Revised Statutes, is
10 amended to read as follows:

11 "**§291-52.6 Replacement of a lost, stolen, or mutilated**
12 **windshield placard or identification card.** A removable
13 windshield placard, temporary removable windshield placard, or
14 identification card that is reported lost, stolen, or mutilated
15 shall be replaced upon [~~the submittal of a~~]:

16 (1) Submittal to the issuing agency of:

17 (A) A written statement by a person with a disability
18 that the placard or identification card was
19 either lost, stolen, or mutilated [~~and a~~];

20 (B) A completed application for a removable
21 windshield placard, temporary removable



1 windshield placard, or identification card to the
2 issuing agency[-]; and

3 (2) Payment of a fee to the issuing agency.

4 All fees collected by the counties for replacement of a lost,
5 stolen, or mutilated windshield placard shall be deposited into
6 the general fund."

7 SECTION 4. Statutory material to be repealed is bracketed
8 and stricken. New statutory material is underscored.

9 SECTION 5. This Act shall take effect upon its approval.
