### A BILL FOR AN ACT

RELATING TO SCHOOL-AGE CHILDREN.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that many children are
- 2 left unsupervised in the mornings and afternoons before and
- 3 after school. Nationally, nearly two-thirds of school-age
- 4 children are in homes where both parents work, but few
- 5 communities have a comprehensive system that provides before-
- 6 and after-school care for children. Currently, Hawaii has a
- 7 successful A+ program for students in grades K-6, but does not
- 8 have a similar program for older children who also need adult
- 9 supervision. Statistics show that the rates of juvenile crime,
- 10 drug use, and experimentation with tobacco, alcohol, and sex
- 11 increase among unsupervised older children during non-school
- 12 hours.
- 13 The legislature further finds that there is widespread
- 14 agreement that it is important to establish safe and structured
- 15 learning environments for school-age children during non-school
- 16 hours.
- 17 The purpose of this Act is to appropriate funds for non-
- 18 school hour programs for school-age children.

## S.B. NO. 179

1 SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 2 much thereof as may be necessary for fiscal year 2007-2008, and 3 the same sum, or so much thereof as may be necessary, for fiscal 4 year 2008-2009, for non-school hour programs for kindergarten 5 through twelfth grades for the department of education. 6 7 The sum appropriated shall be expended by the department of education for the purposes of this Act. 8 SECTION 3. There is appropriated out of the general 9 revenues of the State of Hawaii the sum of \$ 10 much thereof as may be necessary for fiscal year 2007-2008, and 11 the same sum, or so much thereof as may be necessary, for fiscal 12 year 2008-2009, for the office of youth services for non-school 13 hour programs for children and youth enrolled in school. 14 The sum appropriated shall be expended by the department of 15 human services for the purposes of this Act. 16 SECTION 4. There is appropriated out of the general 17 revenues of the State of Hawaii the sum of \$ 18 , or so much thereof as may be necessary for fiscal year 2007-2008, and 19 the same sum, or so much thereof as may be necessary, for fiscal 20 year 2008-2009, for non-school hour programs for children and 21 22 youth enrolled in school.

# S.B. NO. 1179

The sum appropriated shall be expended by the department of 1 parks and recreation of each county, subject to the following 2 allocation percentages, which are based on the number of 3 children eighteen years of age or younger residing in each 4 county; provided that no funds shall be disbursed unless each 5 6 county provides matching funds on a dollar-for-dollar basis: Seventy-one per cent, city and county of Honolulu; 7 (1)Thirteen per cent, county of Hawaii; 8 (2)Eleven per cent, county of Maui; and 9 (3)10 Five per cent, county of Kauai. (4)SECTION 5. Moneys allocated for the purposes of this Act 11 shall not reduce existing funding for non-school hour programs. 12 Moneys shall be awarded by the expending agencies only to non-13 school hour programs that demonstrate a commitment to partnering 14 with the public and private sectors and involve youth as active 15 participants in all phases of program planning, implementation, 16 and evaluation. All programs that receive those moneys shall 17 meet each quarter with their community partners for the purposes 18 of program evaluation and improvement. 19 SECTION 6. The department of education, the office of 20 youth services, and the counties' parks and recreation 21 departments shall convene annually to share information on the 22

- 1 best practices and outcomes of non-school hour programs. The
- 2 office youth services shall submit to the legislature an annual
- 3 report on the programs funded under this Act no later than
- 4 twenty days prior to the convening of each regular session,
- 5 beginning with the regular session of 2008.

6 SECTION 7. This Act shall take effect on July 1, 2007.
