## A BILL FOR AN ACT

RELATING TO LEASING OF STATE SUBMERGED LANDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 171-53, Hawaii Revised Statutes, is
- 2 amended by amending subsection (c) to read as follows:
- 3 (c) (1) The board, with the prior approval of the governor
- 4 and, except as provided in paragraph (2), the prior
- 5 authorization of the legislature by concurrent resolution, may
- 6 lease state submerged lands and lands beneath tidal waters under
- 7 the terms, conditions, and restrictions provided in this
- 8 chapter; provided that the authorization of the legislature
- 9 shall not be required for leases issued under chapter 190D; and
- 10 provided further that the approval of the governor and
- 11 authorization of the legislature shall not be required for any
- 12 grant of easement or lease of state submerged lands or lands
- 13 beneath tidal waters used for moorings, cables, pipelines, or
- 14 noncommercial piers; provided further that this exemption shall
- 15 not apply to easements for cables used for inter-island
- 16 electrical transmission or slurry pipelines used for

- 1 transportive materials, mined at sea, or waste products from the
- 2 processing of the same.
- The requirement of prior authorization of the 3
- legislature by concurrent resolution in paragraph (1) with 4
- 5 respect to any lease of state submerged lands and lands beneath
- 6 tidal waters shall not apply to such lands at any exempt harbor.
- 7 (3) For purposes of paragraph (2), an "exempt harbor" is
- any of the following small boat harbors: Hale O Lono Harbor (on 8
- the island of Molokai), Kahului (on the island of Maui), Keehi 9
- 10 Harbor Lagoon (on the island of Oahu), Nawilili Harbor (on the
- island of Kauai), or [Honokohau Boat Harbor] [Keauhou Boat 11
- 12 Harbor] [Kailua-Kona] (on the island of Hawaii).
- (4) The lease shall provide that the lands shall be 13
- 14 reclaimed at the expense of the lessee. Title to the reclaimed
