PURPOSE:

The entire leeward (Waianae) coast has levels of poverty in excess of twenty percent in each of the census tracts comprising the Waianae community. This condition has existed for over forty years despite the efforts of federal, state, and city and county programs to alleviate the suffering or reduce the numbers of individuals and families impacted.

This measure seeks to provide financial assistance to foster community-based economic development on the leeward coast.

Impact on the public: Provide training and capacity-building opportunities, and invest, through grants and low-interest loans, in community economic development projects that result in measurable economic impact.
