### JUSTIFICATION SHEET

DEPARTMENT:

TITLE:

A BILL FOR AN ACT RELATING TO CONTROLLED

SUBSTANCES.

PURPOSE:

The purpose of this bill is to amend section 329-59, Hawaii Revised Statutes (HRS), to authorize the use of the controlled substance registration revolving fund to offset the cost of the Department of Public Safety Narcotic Enforcement Division's (NED) forensic drug laboratory and costs associated with investigating violations relating to violations of the Uniform Controlled Substance Act, Chapter 329 HRS.

MEANS:

Amend section 329-59, HRS.

JUSTIFICATION:

During the 2004 legislative session, NED was authorized an expenditure ceiling increase of \$100,000 for fiscal year 2004-2005 and \$30,000 for fiscal year 2006 from NED's Controlled Substance Registration Revolving Fund for the initial start up cost of a forensic drug laboratory located in the Narcotics Enforcement Division. The Department is requesting that section 329-59, HRS, be amended to reflect that the \$325,000 fund can be utilized to offset the cost of the NED forensic drug laboratory and cost associated with investigating violations relating to the registration and control of controlled substances.

Impact on the public: Allow NED to conduct forensic drug analysis on evidence seized in cases originating from cases imitated by physicians, pharmacies and hospitals.

Impact on the department and other agencies:
This change would benefit the Department of
Public Safety by allowing the Narcotic
Enforcement Division to conduct its own
forensic drug analysis which would benefit
all state agencies which the division
services.
