A BILL FOR AN ACT

RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 10, Hawaii	Revised Statutes, is amended	
2	by adding a new section to be appro	priately designated and to	
3	read as follows:		
4	"§10- Housing development;	exemption from statutes,	
5	ordinances, charter provisions, rul	es. (a) The office may	
6	develop housing projects that shall	be exempt from all statutes,	
7	ordinances, charter provisions, and rules of any governmental		
8	agency relating to planning, districting, zoning, and		
9	construction standards for subdivisions, development and		
10	improvement of land, and the construction of units thereon;		
11	provided that:		
12	(1) The office finds that the	project is consistent with	
13	the purpose and intent of	this chapter, and meets	
14	minimum requirements of h	ealth and safety;	
15	(2) The development of the pr	oposed project does not	
16	contravene any safety standards, tariffs, or rates and		
17	fees approved by the publ	ic utilities commission for

1		public utilities or the various boards of water supply	
2		authorized under chapter 54; and	
3	(3)	The office consults during the project planning phase	
4		with the county in which the project will be located	
5		to receive any county concerns and county	
6		recommendations about the project.	
7	<u>(b)</u>	For the purpose of this section, "housing project"	
8	means a p	roject of affordable housing or workforce housing;	
9	providing	that "affordable housing" and "workforce housing", in	
10	the conte	xt of identifying the persons or families intended to	
11	be served by such housing, primarily includes for-sale housing		
12	or rental	housing for persons or families whose incomes are	
13	identifie	d as one hundred forty per cent or less of the area	
14	median in	come for each of the counties of Hawaii, Maui,	
15	Honolulu,	and Kauai as determined by the United States	
16	<u>Departmen</u>	t of Housing and Urban Development from time to time,	
17	and as ad	justed by family size. These persons or families	
18	include t	he following income groups:	
19	(1)	"Very low income" means those earning fifty per cent	
20		or less of the area median income;

2		cent and up to eighty per cent of the area median
3		income;
4	(3)	"Low-moderate income" means those earning more than
5		eighty per cent and up to one hundred twenty per cent

8		hundred twenty per cent and up to one hundred forty
9		per cent of the area median income."

Allows the office of Hawaiian affairs to develop housing projects that are exempt from all statutes, ordinances, charter provisions, and rules of any governmental agency relating to planning, districting, zoning, construction standards for subdivisions, development and improvement of land, and the construction of units.
