## A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR THE PUNA DISTRICT POLICE STATION IN KEA'AU, HAWAI'I.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The district of Puna is the third largest
- 2 police district in the county of Hawai'i and consists of
- 3 approximately four hundred ninety-nine square miles. According
- 4 to the 2000 census, the district accounts for approximately
- 5 twenty-one per cent of the island's population and drew
- 6 approximately 10,554 new residents during the last decade,
- 7 thereby becoming the fastest growing district on the island of
- 8 Hawai'i. The current police station in Kea'au, Hawai'i was
- 9 originally built in 1969 and expanded in 1986. At the time of
- 10 the last expansion, the structure housed thirty-three sworn
- 11 personnel and one clerical position. Since then, the police
- 12 station workforce has increased to fifty-three sworn personnel
- 13 and two civilian positions. The facility is located on land
- 14 that has no additional space for improvements or expansions.
- 15 The current facility is cramped and only has a single
- 16 interview and waiting room for use by both victims and suspects.
- 17 Locker room facilities are inadequate, as there is only one

- 1 shower, one lavatory, and one sink for all male employees to
- 2 share. The break room is the size of a walk-in pantry.
- 3 Officers can reheat their meals and get a cup of coffee, but
- 4 there is not enough room for a table or chairs for officers to
- 5 use during their break.
- 6 A new facility would need to house seventy sworn personnel
- 7 and four civilian employees, interview rooms, holding cells, an
- 8 evidence room, public reception area with adequate security
- 9 partitions, adult offender processing rooms, and separate
- 10 facilities to process juvenile offenders. The new facility
- 11 would also have to be in compliance with the requirements of the
- 12 Americans With Disabilities Act. The total cost of the
- 13 facility, including planning, design, and construction costs, is
- 14 estimated at \$6,500,000.
- 15 SECTION 2. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$6,500,000, or so
- 17 much thereof as may be necessary for fiscal year 2007-2008, for
- 18 a grant-in-aid to the county of Hawai'i for the planning,
- 19 design, and construction of the Puna district police station in
- 20 Kea'au, Hawai'i.
- 21 The sum appropriated shall be expended by the county of
- 22 Hawai'i for the purposes of this Act.



1 SECTION 3. This Act shall take effect on July 1, 2007.
