A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR THE WAIANAE COAST COMPREHENSIVE HEALTH CENTER EMERGENCY ROOM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Waianae Coast 2 Comprehensive Health Center was established in 1973, at which
- 2 Comprehensive Health Center was established in 1973, at which
- 3 time Waianae qualified as a medically underserved area, pursuant
- 4 to federal guidelines, with operational funds granted through
- 5 the United States Public Health Service. The legislature
- 6 further finds that around 1986, with assistance from the Aloha
- 7 United Way, the Waianae Coast Comprehensive Health Center's
- 8 emergency room was opened twenty-four hours per day, three
- 9 hundred sixty-five days a year. Over the years, the Waianae
- 10 Coast Comprehensive Health Center has been able to secure
- 11 various grants and successfully raise capital for improvements
- 12 and expansion of the center and its programs and services. The
- 13 legislature further finds that today, as was true from its
- 14 establishment, the Waianae Coast Comprehensive Health Center
- 15 continues to fulfill its mission as a community-owned and
- 16 community-operated nonprofit medical facility serving an ever-
- 17 expanding Waianae coast community of some 50,000 residents.

- 1 However, additional funding is needed to allow the Waianae Coast
- 2 Comprehensive Health Center to continue to faithfully serve
- 3 residents of the Waianae coast through the provision of twenty-
- 4 four hour per day emergency room services.
- 5 The purpose of this Act is to assist the Waianae Coast
- 6 Comprehensive Health Center in providing continuing twenty-four
- 7 hours per day emergency room services to residents of the
- 8 Waianae coast.
- 9 SECTION 2. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of \$1,500,000, or so
- 11 much thereof as may be necessary for fiscal year 2007-2008, and
- 12 the same sum, or so much thereof as may be necessary for fiscal
- 13 year 2008-2009, as a grant pursuant to chapter 42F, Hawaii
- 14 Revised Statutes, to the Waianae Coast Comprehensive Health
- 15 Center for the operation of its twenty-four hour emergency room.
- 16 The sums appropriated shall be expended by the department
- 17 of health for the purposes of this Act.
- 18 SECTION 3. This Act shall take effect on July 1, 2007.
