## A BILL FOR AN ACT

RELATING TO OFFENSES AGAINST THE PERSON.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 707-711, Hawaii Revised Statutes, is 2 amended by amending subsection (1) to read as follows: "(1) A person commits the offense of assault in the second 3 4 degree if: 5 (a) The person intentionally or knowingly causes substantial bodily injury to another; 6 (b) The person recklessly causes serious or substantial 7 bodily injury to another [person]; 8 9 (c) The person intentionally or knowingly causes bodily injury to a correctional worker, as defined in section 10 710-1031(2), who is engaged in the performance of duty 11 or who is within a correctional facility; 12 13 (d) The person intentionally or knowingly causes bodily injury to another [person] with a dangerous 14 instrument; [ex] 15 The person intentionally or knowingly causes bodily 16 (e) 17 injury to an educational worker who is engaged in the
