A BILL FOR AN ACT

RELATING TO THE STATE CAPITOL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 21E-2, Hawaii Revised Statutes, is
2	amended b	y amending subsection (a) to read as follows:
3	"(a)	There is established within the legislature a
4	bipartisa	n joint legislative management committee to
5	[supervis	e,] <u>:</u>
6	(1)	Supervise develop policy, and coordinate activities
7		for all legislative service agency staff services [+];
8		and
9	(2)	In conjunction with the department of accounting and
10		general services, jointly manage and control the state
11		capitol building and grounds in accordance with
12		sections 21E-4 and 26-6; provided that notwithstanding
13		any other law to the contrary, the management and
14		control of the entire state capitol building and
15		grounds, including its parking facilities, shall be
16		under the joint management of the legislature, through
17		the joint legislative management committee, and the

1	department of accounting and general services in
2	accordance with sections 21E-2, 21E-4, 26-6 and
3	chapter 22."
4	SECTION 2. Section 21E-4, Hawaii Revised Statutes, is
5	amended to read as follows:
6	"[+] §21E-4[+] Powers and duties. The committee shall be
7	responsible for establishing general policy and evaluating,
8	supervising, and coordinating activities among the legislative
9	service agencies. The committee shall:
10	(1) Determine the types, quantity, and quality of tasks t
11	be assigned to each legislative service agency within
12	statutory limitations; provided that with respect to
13	direction to the auditor to conduct investigations
14	pursuant to [Article] article VII, section 10 of the
15	Constitution of the State, direction shall be by both
16	houses of the legislature;
17	(2) Evaluate and recommend the budget of each legislative
18	service agency to the legislature;
19	(3) Approve annually the salary pay ranges to be used in
20	determining the salaries of the staffs of legislative
21	service agencies. Legislative service agency
22	directors shall determine the salaries to be paid to

1		their respective scarrs in accordance with the pay
2		ranges. Each legislative service agency director
3		shall file a report annually with the committee
4		setting forth the salaries paid to their respective
5		staffs;
6	(4)	Meet at times as it may determine to carry out its
7		policy-making duties;
8	(5)	Evaluate ways to improve legislative service agency
9		staff services and organization, including but not
10		limited to: operations of legislative service
11		agencies, management of legislative business,
12		legislative compensation, legislative information
13		systems, legislative office space, and efficient use
14		of state capitol facilities;
15	(6)	Supervise the development, operation, and maintenance
16		of legislative information processing systems,
17		including but not limited to approving and monitoring
18		joint computer operations in the legislative process;
19	<u>(7)</u>	In conjunction with the department of accounting and
20		general services, jointly manage and control the state
21		capitol building and grounds, including determining:

1		(A) Which individuals and agencies may occupy
2		portions of the building under its control,
3		including state capitol parking facilities; and
4		(B) Who may enter into contracts for maintenance and
5		other services for the state capitol building and
6		grounds;
7		Notwithstanding any other law to the contrary, the
8		management and control of the entire state capitol
9		ouilding and grounds, including its parking
10		facilities, shall be under the joint management of the
11		legislature, through the joint legislative management
12		committee, and the department of accounting and
13		general services in accordance with sections 21E-2,
14		21E-4, 26-6 and chapter 22;
15	[-(7)-]	(8) Adopt rules as necessary for the purposes of this
16		chapter; and
17	[(8)]	(9) Do all things necessary and proper to carry out
18		the purposes of this chapter."
19	SECT	ON 3. Section 26-6, Hawaii Revised Statutes, is
20	amended by	amending subsection (b) to read as follows:
21	" (b)	The department shall:

1	(1)	Preaudit and conduct after-the-fact audits of the
2		financial accounts of all state departments to
3		determine the legality of expenditures and the
4		accuracy of accounts;
5	(2)	Report to the governor and to each regular session of
6		the legislature as to the finances of each department
7		of the State;
8	(3)	Administer the state risk management program;
9	(4)	Establish and manage motor pools;
10	(5)	Manage the preservation and disposal of all records of
11		the State;
12	(6)	Undertake the program of centralized engineering and
13		office leasing services, including operation and
14		maintenance of public buildings, for departments of
15		the State; provided that the state capitol building
16		and grounds shall be jointly managed and controlled in
17		conjunction with the joint legislative management
18		committee pursuant to sections 21E-2, 21E-4, and 26-6;
19		and provided further that notwithstanding any other
20		law to the contrary, the management and control of the
21		entire state capitol building and grounds, including
22		its parking facilities, shall be under the joint

1		management of the legislature, through the joint
2		legislative management committee, and the department
3		of accounting and general services in accordance with
4		sections 21E-2, 21E-4, 26-6 and chapter 22;
5	(7)	Undertake the functions of the state surveyor;
6	(8)	Establish accounting and internal control systems;
7	(9)	Provide centralized computer information management
8		and processing services, coordination in the use of
9		all information processing equipment, software,
10		facilities, and services in the executive branch of
11		the State, and consultation and support services in
12		the use of information processing and management
13		technologies to improve the efficiency, effectiveness,
14		and productivity of state government programs; and
15	(10)	Establish, coordinate, and manage a program to provide
16		a means for public access to public information and
17		develop and operate an information network in
18		conjunction with its overall plans for establishing a
19		communication backbone for state government."
20	SECT	ION 4. Section 30-3, Hawaii Revised Statutes, is
21	amended by	y amending subsection (a) to read as follows:

1	"(a)	The comptroller shall provide, upon request, to each
2	governor-	elect, for use in connection with the governor-elect's
3	preparati	ons for the assumption of official duties as governor,
4	necessary	services and facilities, including:
5	(1)	Suitable office space appropriately equipped with
6		furniture, furnishings, office machines and equipment,
7		and office supplies as determined by the comptroller
8		after consultation with the governor-elect, within the
9		state capitol complex; provided that no:
10		(A) Office space;
11		(B) Appurtenant furniture or furnishings;
12		(C) Office machines and equipment;
13		(D) Office supplies;
14		(E) Personnel; or
15		(F) Parking facilities;
16		that are under the joint management and control of the
17		joint legislative management committee and the
18		department of accounting and general services shall be
19		assigned to the governor-elect;
20	(2)	Payment of the compensation of members of office
21		staffs designated by the governor-elect at rates
22		determined by the governor-elect; provided that [any]:

2		government may be detailed to [such] those staffs
3		on a reimbursable or nonreimbursable basis; and
4		while so detailed [such] the employee shall be
5		responsible only to the governor-elect for the

8	(B)	Any employee so detailed shall continue to
9		receive the compensation provided pursuant to law
10		for the employee's regular employment, and shall
11		retain the rights and privileges of [such] that
12		employment without interruption. Notwithstanding
13		any other law to the contrary, persons receiving
14		compensation as members of office staffs under
15		this paragraph, other than those detailed from
16		agencies, shall not be held or considered to be
17		employees of the state government except for
18		purposes of the public employees retirement
19		system;

(3) Payment of expenses for the procurement of services of

experts or consultants or organizations thereof for

1		the governor-elect at rates not to exceed \$100 per
2		diem for individuals;
3	(4)	Payment of travel expenses and subsistence allowances,
4		not to exceed that authorized for other state
5		employees, including rental by the state government of
6		hired motor vehicles, found necessary by the governor-
7		elect, as authorized for persons employed
8		intermittently or for persons serving without
9		compensation, as may be appropriate;
10	(5)	Communication services found necessary by the
11		governor-elect; and
12	(6)	Payment of expenses for necessary printing and
13		binding.
14	Each gover	rnor-elect shall be entitled to conveyance of all mail,
15	including	airmail, sent by the governor-elect in connection with
16	the govern	nor-elect's preparations for the assumption of official
17	duties as	governor."
