A BILL FOR AN ACT

RELATING TO OUTDOOR ADVERTISING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that owners and residents 1 2 of residential and agricultural properties should be allowed to display signs and other outdoor advertising devices on their 3 property in a manner that will not, by their size, location, or 4 method of display, interfere with traffic safety or otherwise 5 endanger the public health, safety, and welfare. 6 7 The purpose of this Act is to: Preserve the character of residential and agricultural 8 (1)neighborhoods; 9 Preserve order and cleanliness; 10 (2) Avoid of the appearance of clutter; 11 (3) Protect property values; 12 (4)Avoid the propagation of litter and the growth of 13 (5)weeds around signs; 14 15 (6) Reduce traffic hazards caused by distractions to 16 motorists and impairment of sight lines; (7)Ensure that the State remains an attractive place to 17

live, work, and visit;

- Protect the outstanding scenic beauty of our 1 (8) 2 community; 3 (9) Reduce administrative burdens; and (10) Protect the health, safety, welfare, of the public. 4 It is not the purpose of this Act to regulate or control 5 the copy, content, or viewpoint of any type of sign, nor is it 6 7 the intent of this Act to create any greater or less protection 8 for any specific type of speech, commercial or non-commercial. SECTION 2. Chapter 445, Hawaii Revised Statutes, is 9 amended by adding a new section to be appropriately designated 10 11 and to read as follows: "§445- Residential property limitations. (a) No sign, 12 billboard, or outdoor advertising device under section 445-112 13 14 displayed on residential or agricultural property may be larger than four feet by two feet, provided that the total area of all 15 signs for each residential or agricultural property unit does 16 17 not exceed sixteen square feet. (b) No sign, billboard, or outdoor advertising device 18 under section 445-112 may be displayed on residential or 19 20 agricultural property if the tenant or owner of the property has received any payment, fee, or valuable consideration in return 21

for the display.

1	(c) In a multi-unit residential structure, each separate
2	unit shall be entitled to display signs, billboards, or outdoor
3	advertising devices meeting the requirements listed in
4	subsection (a); provided that multi-unit residential structures
5	with four or more units may display signs on their common areas
6	that are no larger than eight feet by four feet, provided
7	further that the total area of all signs in the common areas
8	does not exceed sixty-four square feet.
9	(d) Nothing in this section is intended to permit any
10	sign, billboard, or outdoor advertising device otherwise
11	prohibited by county ordinance.
12	(e) For purposes of this section, the terms "residential
13	or agricultural property" and "residential or agricultural
14	property unit" refer to separate residential or agricultural
15	properties that have separate tax map keys."

17	SECTION 4. This Act shall take effect July 1, 2007.
