A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that a growing number of public school systems nationwide have hired in-house legal 2 counsel to address, monitor, and manage the vast amounts of 3 legal work generated by the operation of public schools in their 4 5 respective school districts. Most of the ten largest school districts in the United States have a legal department or office 6 of general counsel to handle the legal affairs of schools. 7 Act 51, Session Laws of Hawaii 2004 (Act 51), known as the 8 9 "Reinventing Education Act of 2004," implemented a comprehensive 10 education reform of Hawaii's public schools upon a legislative finding in section 1 of the Act that stated in part: 11 12 The legislature finds that significant changes need to be made to enhance Hawaii's public education system to 13 ensure the success of that journey. Although the State's 14 students, parents, teachers, school administrators, 15 departmental staff, and other educational stakeholders 16

strive to achieve excellence, their efforts will never be

1	completely successful until various aspects of the system
2	around them are improved.
3	The legislature has supported and will continue to
4	support efforts by the department of education to improve
5	Hawaii's schools as a means of enhancing the academic
6	achievement, safety and well being, and civic commitment of
7	students, to meet the evolving needs of today's
8	communities.
9	The legislature further finds that the department of the
10	attorney general currently is responsible for responding to
11	requests for legal opinions from the department of education.
12	However, the deputy attorneys general are not available on a
13	full-time, day-to-day basis to advise the department of
14	education as legal matters arise in the course of conducting the
15	multiplicity and complexity of educational reform operations
16	required by Act 51. Prudence would dictate that full-time legal
17	representation should be available on a continuing daily basis
18	in order to identify and resolve legal issues before litigation
19	arises. Act 51 is landmark and complex legislation that
20	requires such full-time legal representation for the department
21	of education.

1 The purpose of this Act is to allow the department of education to hire in-house attorneys independent of the 2 3 department of the attorney general. SECTION 2. Section 28-8.3, Hawaii Revised Statutes, is 4 amended by amending subsection (a) to read as follows: 5 No department of the State other than the attorney 6 general may employ or retain any attorney, by contract or 7 otherwise, for the purpose of representing the State or the 8 department in any litigation, rendering legal counsel to the 9 department, or drafting legal documents for the department; 10 provided that the foregoing provision shall not apply to the 11 employment or retention of attorneys: 12 13 By the public utilities commission, the labor and (1)industrial relations appeals board, and the Hawaii 14 labor relations board; 15 16 By any court or judicial or legislative office of the (2) 17 State; By the legislative reference bureau; 18 (3) 19 (4)By any compilation commission that may be constituted from time to time: 20 By the real estate commission for any action involving 21 (5)
