A BILL FOR AN ACT

RELATING TO CAREGIVING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature established the Joint
- 2 Legislative Committee on Family Caregiving (JLCFC) pursuant to
- 3 Act 285, Session Laws of Hawaii (SLH) 2006, and JLCFC was
- 4 further extended to June 30, 2008, under Act 204, SLH 2007 (Act
- 5 204). JLCFC has been diligent in its role to strengthen support
- 6 to family caregivers through various means. One of these means
- 7 of support is respite care.
- 8 The Legislative Reference Bureau conducted a study pursuant
- 9 to House Concurrent Resolution No. 187, adopted during the
- 10 regular session of 2007 (H.C.R. No. 187), on how other states
- 11 address the issue of respite care. The report indicated that
- 12 respite has been shown to be beneficial in lowering stress and
- 13 other negative consequences of caregiving. Additionally, a
- 14 comprehensive family caregiver needs assessment conducted
- 15 pursuant to Act 204 also indicated that respite care is one of
- 16 the top choices of assistance that caregivers feel would be
- 17 helpful.

         Respite care can relieve the everyday stress of providing
 2
    round-the-clock care. However, there are times when emergency
 3
    respite care becomes critical when a family caregiver is
 4
    unexpectedly unable to provide care because of illness, an
 5
    accident, or other reasons.
 6
         More needs to be done to determine the full inventory of
7
    respite care providers and the specific types of respite care
8
    provided in the state. The types of respite care can include
9
    planned respite care, short term respite, or emergency respite
10
    care. Additionally, although respite services may be available,
11
    caregivers are not always aware that such services are
12
    available, or may not know where to go to seek assistance.

         The purpose of this Act is to appropriate funds to the
14
    executive office on aging to continue its respite inventory
15
    project pursuant to H.C.R. No. 187, in collaboration with the
16
    university of Hawaii at Manoa school of social work.

         SECTION 2. There is appropriated out of the general

    revenues of the State of Hawaii the sum of $
