A BILL FOR AN ACT

RELATING TO DENTISTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 346-59, Hawaii Revised Statutes, is
2	amended by amending subsection (b) to read as follows:
3	"(b) Rates of payment to providers of medical care who are
4	individual practitioners, including doctors of medicine,
5	[dentists, psychologists, osteopaths,
6	optometrists, and other individuals providing services, shall be
7	based upon the Hawaii medicaid fee schedule[\div]; provided that
8	rates of payment to dentists shall be based on the seventy-fifth
9	percentile of the usual, customary, and reasonable fee
10	established by insurers for services provided by dentists. For
11	the purposes of this section, the term "usual, customary, and
12	reasonable fee" means:
13	(1) Usual fee: The fee that an individual dentist most
14	frequently charges for a specific dental procedure;
15	(2) Customary fee: The fee determined from actual fees
16	submitted for a specific dental procedure. The

1	customary fee establishes the maximum benefit payable
2	for that procedure; and
3	(3) Reasonable fee: The fee charged by a dentist for a
4	specific dental procedure that has been modified by
5	complications or unusual circumstances.
6	[The] Except for payments to dentists, the amounts paid shall
7	not exceed the maximum permitted to be paid individual
8	practitioners or other individuals under federal law and
9	regulation, the medicare fee schedule for the current year, the
10	state limits as provided in the appropriation act, or the
11	provider's billed amount.
12	The appropriation act shall indicate the percentage of the
13	medicare fee schedule for the year 2000 to be used as the basis
14	for establishing the Hawaii medicaid fee schedule. For any
15	subsequent adjustments to the fee schedule, the legislature
16	shall specify the extent of the adjustment in the appropriation
17	act."
18	SECTION 2. Statutory material to be repealed is bracketed
19	and stricken. New statutory material is underscored.
20	SECTION 3. This Act shall take effect upon its approval.
