A BILL FOR AN ACT

RELATING TO DENTISTRY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 448, Hawaii Revised Statutes, is
- 2 amended by adding two new sections to be appropriately
- 3 designated and to read as follows:
- 4 "§448-A Prohibition on interference. (a) No person or
- 5 entity without a license issued pursuant to this chapter shall
- 6 direct or interfere with a licensed dentist's judgment and
- 7 competent practice of dentistry.
- **8** (b) No dentist licensed pursuant to this chapter who
- 9 engages in the practice of dentistry in any form, shall permit a
- 10 person or entity, other than a dentist licensed pursuant to this
- 11 chapter, to direct, participate in, or interfere with the
- 12 licensee's practice of dentistry.
- 13 (c) The board shall establish a list of activities that
- 14 should be performed or controlled in the sole discretion of
- 15 dentists licensed pursuant to this chapter.

- 20 SECTION 4. This Act shall take effect upon its approval.
