A BILL FOR AN ACT

RELATING TO HEALTH INSURANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) There is established the state health
- 2 authority task force. The task force shall research, evaluate,
- 3 and develop a comprehensive plan that establishes the state
- 4 health authority, a single state agency that shall be
- 5 responsible for the overall health planning for the State and
- 6 shall be responsible for determining future capacity needs of
- 7 health providers, facilities, equipment, and support services
- 8 providers.
- 9 (b) The task force shall be composed of eleven members,
- 10 three to be appointed by the governor, three appointed by the
- 11 president of the senate, and three appointed by the speaker of
- 12 the house of representatives. The remaining two shall be
- 13 appointed by the governor from the health care industry. There
- 14 shall also be three ex officio members who are:
- 15 (1) The director of health or the director's designee;
- 16 (2) The director of business, economic development, and
- 17 tourism or the director's designee; and

1	(3)	The insurance commissioner or the insurance
2		commissioner's designee.
3	(c)	The task force shall research, evaluate, and develop a
4	plan for	the state health authority that includes:
5	(1)	Providing state-funded health insurance for
6		individuals with incomes up to three hundred per cent
7		of the federal poverty level who are otherwise
8		eligible for benefits under the state's medicaid
9		programs, including QUEST;
10	(2)	Adopting all optional services allowed under the
11		medicaid programs; and
12	(3)	Providing the board of trustees of the Hawaii
13		employer-union health benefits trust fund authority to
14		transfer moneys from the respective funds to the
15		authority.
16	(d)	The task force shall develop a plan that enables the
17	state hea	lth authority to purchase all health care based on
18	assessing	the feasibility of:
19	(1)	Reimbursing all certified health care providers at a
20		rate to be determined by the authority within thirty
21		days of the provision of care;

	(2)	is confishing an emproyer nearth insurance assessment
2		formula to collect from each employee earning a wage
3		or salary in the State that is based on a percentage
4		of the employee's monthly or hourly wage; and
5	(3)	Collecting or receiving, for purposes of funding the
6		authority's purchase of health care, the following:
7		(A) The employer health insurance assessment for each
8		individual who earns a wage or salary in the
9		State, including the current medical portion of
10		workers' compensation insurance;
11		(B) Federal medicaid matching funds;
12		(C) State general fund appropriations;
13		(D) Self-employed health insurance assessments from
14		individuals who are self-employed, as
15		differentiated from the employee health insurance
16		assessment; and
17		(E) Individual monthly dues and the medical payment
18		portions as determined by audit of 2002 premiums
19		covering:
20		(i) Automobile insurance policy premiums;
21		(ii) Public liability insurance premiums; and
22		(iii) Homeowners insurance policy premiums;

1		paid to the authority by insurance carriers on a	
2		monthly basis.	
3	(e)	The task force shall develop a detailed plan to enable	
4	the state	health authority to purchase all health care for all	
5	residents	of the State no later than January 1, 2010.	
6	(f)	The task force shall also:	
7	(1)	Reevaluate the Prepaid Health Care Act and search for	
8		other viable options for universal health care	
9		coverage; and	
10	(2)	Determine a funding mechanism using the employees,	
11		medicaid waiver funds, appropriations, and the health	
12		benefits portion of different types of insurance	
13		including homeowners, automobile, and liability	
14		insurance to draw on federal matching funds.	
15	(g)	The task force shall submit its final report,	
16	including	findings, recommendations, and proposed legislation to	
17	the legisl	ature no later than twenty days prior to the convening	
18	of the regular session of 2009.		
19	(h)	The task force shall convene its first meeting no	
20	later than	July 15, 2008 and shall terminate on June 30, 2009.	

SECTION 2. This Act shall take effect on July 1, 2008.
