A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The federal Individuals with Disabilities
- 2 Education Act requires that each state establish and maintain a
- 3 state advisory panel on the education of children with
- 4 disabilities. The Act further states that the advisory panel
- 5 must be appointed by the governor or any other official
- 6 authorized under state law to make those appointments; provided
- 7 that if a state has an existing advisory panel that can perform
- 8 the required functions, the state may modify the existing panel
- 9 so that it fulfills all of the requirements, instead of
- 10 establishing a new advisory panel. In Hawaii, the advisory
- 11 panel is the Special Education Advisory Council, and members are
- 12 appointed by the superintendent of education.
- 13 The purpose of this Act is to establish the special
- 14 education advisory council in chapter 302A, Hawaii Revised
- 15 Statutes, with members to be appointed by the governor.

         SECTION 2. Chapter 302A, Hawaii Revised Statutes, is

    amended by adding a new section to be appropriately designated

    and to read as follows:

         "§302A- Special education advisory council. (a) There
    is established a special education advisory council that shall

    be placed within the department for administrative purposes.

    The council shall consist of twenty-two members appointed by the
8
    governor as provided in section 26-34. In making appointments
9
    to the council, the governor shall ensure that members are
10
    broadly representative of the state population and are involved
11
    in or concerned with the education of children with
12
    disabilities. The majority of members shall be individuals with
13
    disabilities or parents of children with disabilities.

    Membership shall include representation from the following;

- 1 (b) Members shall be appointed for a three-year term 2 commencing July 1 of each year; provided that the student 3 representative or representatives shall be appointed for a one-4 year term commencing July 1 of each year. Except with respect 5 to a student representative, the terms shall be staggered; one-6 third of the membership shall be appointed each year. 7 executive committee of the council shall develop and transmit to 8 the governor in May of each year, a list of persons to fill 9 expired terms. The executive committee of the council shall 10 also develop and transmit to the governor, a list of persons to 11 fill vacancies as they occur. (c) A quorum shall consist of one-half of the current 12 13 membership. Members who are absent without prior notice two 14 times during the school year will be contacted by the 15 chairperson to determine interest in membership. Three absences 16 without prior notification shall result in a recommendation to 17 the governor that the person's membership be terminated and a 18 replacement appointed. Members who wish to resign from the 19 council shall submit a written notice to the chairperson who 20 shall forward the resignation to the executive committee for 21 action.

2	and vice chairperson and shall serve without compensation;
3	provided that actual travel and other expenses incurred in the
4	performance of their duties shall be advanced or reimbursed.
5	(e) By July 1 of each year, the advisory council shall
6	submit an annual report of council activities and suggestions to
7	the department of education. This report shall be made
8	available to the public."
9	SECTION 3. New statutory material is underscored.
10	SECTION 4. This Act shall take effect upon its approval.
