### A BILL FOR AN ACT

RELATING TO MOTOR VEHICLES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the use of hybrid
- 2 and alternative fuel motor vehicles supports fuel efficient
- 3 technologies, decreases Hawaii's dependence on imported fuel
- 4 oils, and decreases harmful emissions that contribute to
- 5 environmental decay and global warming.
- 6 The purpose of this Act is to provide incentives to
- 7 purchase and use hybrid and alternative fuel motor vehicles by
- 8 allowing these vehicles to travel in high-occupancy vehicle
- 9 lanes.
- 10 SECTION 2. Section 291C-222, Hawaii Revised Statutes, is
- 11 amended to read as follows:
- 12 "\$291C-222 Designation of high occupancy vehicle lane.
- 13 (a) The director of transportation by rules adopted in
- 14 accordance with chapter 91, and the counties by ordinance, may
- 15 designate high occupancy vehicle lanes as to roadways under
- 16 their respective jurisdictions.
- 17 (b) Signs and other official traffic-control devices that
- 18 designate high occupancy vehicle lanes shall be placed and SB LRB 08-0191.doc

- 1 maintained to advise drivers of the high occupancy vehicle
- 2 requirement and the hours of usage. When the high occupancy
- 3 vehicle lane also serves as a contra-flow lane, the hours of
- 4 usage as a high occupancy vehicle lane shall be the time when
- 5 the lane is coned for use as a high occupancy vehicle lane.
- 6 (c) No motor vehicle shall be operated upon these lanes
- 7 except in conformance with the instructions on the signs and
- 8 other official traffic-control devices.
- 9 (d) A hybrid motor vehicle or an alternative fuel motor
- 10 vehicle may use any high occupancy vehicle lane as provided
- 11 under this section, regardless of the number of occupants in the
- 12 vehicle.
- 13 For the purposes of this section:
- "Alternative fuel motor vehicle" means a motor vehicle that
- 15 is propelled by the use of an alternative fuel as that term is
- 16 defined in section 243-1; and
- 17 "Hybrid motor vehicle" means a motor vehicle with a hybrid
- 18 propulsion system that uses a combination of electricity and
- 19 combustible fuel.
- 20 [<del>(d)</del>] (e) A motorcycle may use any high occupancy vehicle
- 21 lane, regardless of the number of occupants.

9	(1) Take effect on July 1, 2008;
10	(2) Apply to taxable years beginning after December 31,
11	2007 and ending before January 1, 2010; and
12	(3) Be repealed on January 1, 2010.
