A BILL FOR AN ACT

RELATING TO SMOKING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 328J-1, Hawaii Revised Statutes, is
2	amended by adding a new definition to be appropriately inserted
3	and to read as follows:
4	""Stand-alone adult entertainment business" means an
5	establishment, including a bar or nightclub that is self-
6	contained and is not part of or connected to a restaurant, in
7	which an activity to which a minor would not be able to legally
8	gain admittance is conducted, including but not limited to:
9	(1) Performing of exotic entertainment;
10	(2) Nude, exotic, or lap dancing; or
11	(3) Showing of film, video, still picture, electronic
12	reproduction, or other visual reproduction depicting:
13	(A) Acts or simulated acts of sexual intercourse,
14	masturbation, sodomy, bestiality, oral
15	copulation, flagellation, or any sexual acts that
16	are prohibited by law;

1	<u>(</u> E	Any person being touched, caressed, or fondled on
2		the breast, buttocks, anus, or genitalia;
3	<u>(C</u>	Scenes wherein a person displays the anus or
4		genitalia; or
5	<u>(D</u>	Scenes wherein artificial devices or inanimate
6		objects are employed to depict, or drawings are
7		employed to portray, any of the prohibited
8		activities described above."
9	SECTION	2. Section 328J-7, Hawaii Revised Statutes, is
10	amended to r	ead as follows:
11	" [-[] §32	8J-7[] Exceptions. Notwithstanding any other
12	provision of	this chapter to the contrary, the following areas
13	shall be exe	mpt from the provisions of sections 328J-3, 328J-4,
14	and 328J-5:	
15	(1) Pr	ivate residences, except when used as a licensed
16	ch	ild care, adult day care, or health care facility;
17	(2) Ho	tel and motel rooms that are rented to guests and
18	ar	e designated as smoking rooms; provided that not
19	mo	re than twenty per cent of rooms rented to guests in
20	a	hotel or motel may be so designated. All smoking
21	ro	oms on the same floor shall be contiguous and smoke
22	fr	om these rooms shall not infiltrate into areas where

1		smoking is prohibited under this chapter. The status
2		of rooms as smoking or nonsmoking may not be changed,
3		except to add additional nonsmoking rooms;
4	(3)	Retail tobacco stores; provided that smoke from these
5		places shall not infiltrate into areas where smoking
6		is prohibited under this chapter;
7	(4)	Private and semiprivate rooms in nursing homes and
8		long-term care facilities that are occupied by one or
9		more persons, all of whom are smokers and have
10		requested in writing to be placed in a room where
11		smoking is permitted; provided that smoke from these
12		places shall not infiltrate into areas where smoking
13		is prohibited under this chapter;
14	(5)	Outdoor areas of places of employment except those
15		covered by the provisions of sections 328J-3 and
16		328J-5;
17	(6)	All areas covered by this chapter when smoking is part
18		of a production being filmed; [and]
19	(7)	State correctional facilities[+]; and
20	(8)	Stand-alone adult entertainment businesses; provided
21		that a clearly legible sign with letters of not less
22		than one inch in height is displayed outside the

1	premises warning the public that the establishment
2	permits smoking within the premises."
3	SECTION 3. Statutory material to be repealed is bracketed
4	and stricken. New statutory material is underscored.
5	SECTION 4. This Act shall take effect yoon its approval.
