RELATING TO THE USE OF FORCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 703-304, Hawaii Revised Statutes, is 1 amended as follows: 2 1. Subsection (2) is amended to read: 3 The use of deadly force is justifiable under this section if [the]: 5 The actor believes that deadly force is necessary to 6 (a) protect [himself] the actor against death, serious 7 8 bodily injury, kidnapping, rape, or forcible sodomy[-]; or 9 The actor uses the deadly force in the actor's 10 (b) dwelling against a person, not lawfully present in the 11 12 actor's dwelling, who uses force against the actor." 2. Subsection (5) is amended to read: 13 14 "(5) The use of deadly force is not justifiable under this section if: 15

1	(a)	The actor, with the intent of causing death or serious
2		bodily injury, provoked the use of force against
3		[himself] the actor in the same encounter; or
4	(b)	The actor knows that [he] the actor can avoid the
5		necessity of using such force with complete safety by
6		retreating or by surrendering possession of a thing to
7		a person asserting a claim of right thereto or by
8		complying with a demand that [he] the actor abstain
9		from any action which [he] the actor has no duty to

Report Title:

Self-Defense; Deadly Force; Duty to Retreat

Description:

Permits the use of deadly force by the resident of a dwelling against person not lawfully in the dwelling who uses force against the resident. Expands the exemption from the duty to retreat from the home and work place to any place where the actor may lawfully be present.
