# A BILL FOR AN ACT

RELATING TO EDUCATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that students in our
- public schools are experiencing increased incidences of violence 2
- 3 and bullying. Indeed, throughout the world, violence and
- killing are daily occurrences that adversely impact attitudes
- 5 and environments in smaller communities, even our schools.
- 6 legislature further finds that efforts to combat the escalating
- 7 violence in our schools has been recently addressed by this
- 8 legislature in 2007, pursuant to house concurrent resolution
- number 55, which requested the department of education to 9
- 10 conduct a study on the feasibility of integrating peace
- 11 education into the public school curriculum and report back to
- 12 the legislature with its findings on the issue.
- 13 One program that has met with great success in spreading
- 14 the message of peace and assisting in conflict resolution is the
- 15 second step program maintained by the Coalition for A Drug-Free
- 16 Hawaii. Implemented in partnership with Kaewai elementary
- school, second step is a school-based violence prevention 17

- 1 program that includes curriculum that teaches students to alter
- 2 their attitudes, reduce impulsive and aggressive behavior, and
- 3 increase their level of social competence. Parental awareness
- 4 and involvement is a component of this program, which has been
- 5 adapted for native Hawaiian individuals through work with the
- 6 Kamehameha Schools' health, wellness, and family education
- 7 section. The success of this program serves as an example for
- 8 the positive effects of peace education for our youth.
- 9 Accordingly, the legislature remains committed to
- 10 furnishing our students with the necessary tools to cope with
- 11 issues of conflict and violence in their schools and everyday
- 12 lives. The institution of peace education into the current
- 13 public school curriculum will better equip our youth with the
- 14 skills to resolve conflicts, prevent violence, and build greater
- 15 character.
- 16 The purpose of this Act is to appropriate funds for the
- 17 incorporation of peace education into the current public school
- 18 curriculum, including funding for counselor training, expansion
- 19 of the peer education program, and the hiring of additional
- 20 substance abuse counselors.
- 21 SECTION 2. There is appropriated out of the general
- 22 revenues of the State of Hawaii the sum of \$ or so

- 1 much thereof as may be necessary for fiscal year 2008-2009 for
- 2 the incorporation of peace education into the current public
- 3 school curriculum, including funding for counselor training,
- 4 expansion of the peer education program, and the hiring of
- 5 additional substance abuse counselors.
- 6 The sum appropriated shall be expended by the department of
- 7 education for the purposes of this Act.
- 8 SECTION 3. This Act shall take effect on July 1, 2008.
