A BILL FOR AN ACT

RELATING TO HISTORIC PRESERVATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 46, Hawaii Revised Statutes, is amended
- 2 by adding a new section to be appropriately designated and to
- 3 read as follows:
- 4 "§46- Photographs of historic property. Notwithstanding
- 5 any other law to the contrary, each county agency that issues
- 6 building, construction, or development-related permits shall not
- 7 issue any permit allowing the demolition, construction, or other
- 8 alteration of a historic building until after a permit applicant
- 9 provides proof of having provided the department of land and
- 10 natural resources with archival quality black and white
- 11 photographs of the historic building, as required under chapter
- 12 6E."
- 13 SECTION 2. Section 6E-8, Hawaii Revised Statutes, is
- 14 amended by amending subsection (a) to read as follows:
- "(a) Before any agency or officer of the State or its
- 16 political subdivisions commences any project which may affect
- 17 historic property, aviation artifact, or a burial site, the
- 18 agency or officer shall advise the department and allow the

1 department an opportunity for review of the effect of the 2 proposed project on historic properties, aviation artifacts, or burial sites, consistent with section 6E-43, especially those 3 listed on the Hawaii register of historic places. The proposed 4 5 project shall not be commenced, or in the event it has already 6 begun, continued, until the department shall have given its 7 written concurrence. In the case of any building over fifty years old, no demolition, construction, or other alteration of 8 9 the building shall occur until after the responsible agency, 10 officer, or county has transmitted archival quality black and 11 white photographs of that building to the department. 12 The department is to provide written concurrence or non-13 concurrence within ninety days after the filing of a request 14 with the department. The agency or officer seeking to proceed 15 with the project, or any person, may appeal the department's 16 concurrence or non-concurrence to the Hawaii historic places 17 review board. An agency, officer, or other person who is dissatisfied with the decision of the review board may apply to 18 19 the governor, who may request the Hawaii advisory council on 20 historic preservation to report or who may take action as the

governor deems best in overruling or sustaining the department."

    any construction, alteration, disposition or improvement of any

    department of the construction, alteration, disposition, or

Description:

Requires a private or public owner of a historic building to provide archival quality black and white photographs of the building to the department of land and natural resources, as a condition of receiving a permit or approval to demolish, construct, or otherwise alter that building.
