A BILL FOR AN ACT

RELATING TO INSURANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) There is established a joint legislative
- 2 study group on twenty-four-hour coverage to investigate the
- 3 issues involved in implementing twenty-four-hour insurance
- 4 coverage in Hawaii. The study group shall address the means by
- 5 which the State can combine prepaid health care, temporary
- 6 disability insurance, motor vehicle insurance, workers'
- 7 compensation insurance, and other related insurance systems in
- 8 order to prevent duplication of coverage and avoid delays in the
- 9 delivery of health care. The study group shall specifically
- 10 address the issue of allowing an employee to access medical
- 11 services through the routes normally used under prepaid health
- 12 care for services covered by other forms of health benefits
- 13 plans, such as workers' compensation and motor vehicle
- 14 insurance.
- 15 (b) The study group shall develop initiatives to
- 16 effectuate twenty-four-hour coverage, including recommended

- 1 statutory changes to the federal Employee Retirement Income
- 2 Security Act.
- 3 (c) The study group shall be exempt from chapter 92,
- 4 Hawaii Revised Statutes.
- 5 (d) The members of the study group shall be appointed by
- 6 the president of the senate and the speaker of the house of
- 7 representatives. The chairs of the senate committee on
- 8 judiciary and labor and the house of representatives committee
- 9 on labor and public employment shall serve as co-chairs of the
- 10 study group. Members of the study group shall also include:
- 11 (1) The director of labor and industrial relations or the
- director's designee;
- 13 (2) The director of commerce and consumer affairs or the
- 14 director's designee;
- 15 (3) The insurance commissioner or the commissioner's
- designee; and
- 17 (4) Any other individuals deemed to have relevant
- 18 expertise and experience.
- (e) Members of the study group shall receive no additional
- 20 compensation for their services.

2	provide research, clerical, and technical support for the study
3	group.
4	(g) The study group shall cease to exist on June 30, 2009.
5	SECTION 2. The study group shall submit findings and
6	recommendations to the legislature not later than twenty days
7	prior to the convening of the regular session of 2009.
8	SECTION 3. There is appropriated out of the general
9	revenues of the State of Hawaii the sum of \$100,000 or so much
10	thereof as may be necessary for fiscal year 2008-2009 to support
11	the joint legislative study group on twenty-four-hour coverage.
