## A BILL FOR AN ACT

RELATING TO LEGISLATIVE HEARINGS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that public participation
- 2 in the legislative process improves the quality of proposed
- 3 legislation. An opportunity for meaningful public review prior
- 4 to a hearing or vote on any proposed legislation helps to
- 5 increase public trust in government, and ensures that the
- 6 legislature operates with the transparency, dignity, and order
- 7 befitting the State. It follows that there should be no hearing
- 8 or vote on any appropriation and revenue-related bill until at
- 9 least seventy-two hours after the bill's introduction, in order
- 10 to give the public ample opportunity to review and comment on
- 11 proposed legislation.
- 12 This Act shall be known and referred to as the
- 13 "Seventy-Two-Hour Budget Review Act."
- 14 SECTION 2. Chapter 21, Hawaii Revised Statutes, is amended
- 15 by adding a new section to be appropriately designated to read
- 16 as follows:

2	related h	oills; procedures. (a) A legislative body shall not
3	hold a he	earing or vote on an appropriation or revenue-related
4	bill unti	l at least seventy-two hours after the bill has been
5	introduce	ed and made publicly available.
6	(b)	No amendment offered to an appropriation or
7	revenue-r	related bill shall be taken into consideration by any
8	legislati	ve body unless it was made publicly available at least
9	twenty-fo	our hours prior to any vote taken.
10	<u>(c)</u>	No striking amendment shall not be taken into
11	considera	tion by any legislative body unless it was made
12	publicly	available at least forty-eight hours prior to any vote
13	taken.	
14	<u>(d)</u>	The time periods described in this section:
15	(1)	Shall exclude any day that is a Saturday, Sunday, or
16		official state holiday, unless the legislative body
17		considering the measure is in session on such a day;
18	(2)	Shall apply each time a new version of an
19		appropriation or revenue-related bill is considered,
20		which shall include consideration of any conference
21		recommendations; and

1	(3)	May be waived upon a two-thirds vote of the
2		legislative body considering the bill. For measures
3		that are adopted making use of the waiver authorized
4		under this subsection, the text and the committee
5		report of the bill shall be amended where appropriate
6		to add the text: "this committee has waived the
7		people's right for a detailed review of this measure
8		as required under the Seventy-Two-Hour Budget Review
9		Act.
10	<u>(e)</u>	As used in this section:
11	"Leg	islative body" means the legislature, its respective
12	houses, a	nd any committees established thereunder.
13	"Pub.	licly available" means the proposed legislation has
14	been poste	ed on the legislature's website and published in a bill
15	report, co	ommittee report, or conference report.
16	"Reve	enue-related bill" or "revenue-related measure" means
17	any bill a	aimed at raising revenue for any operating, capital, or
18	transporta	ation expense.
19	"Str	iking amendment" means any amendment that would delete
20	all text :	after the title of a hill and insert new text "
