A BILL FOR AN ACT

RELATING TO THE AUDITOR.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that since the passage of
 mandatory minimum sentences for the use, possession, or
 distribution of crystal methamphetamine, Hawaii's prison
 population has dramatically increased. This rise in inmate
 population has caused Hawaii to contract with out-of-state
 private prisons to ease overcrowding.

7 The legislature also finds that, in 1996, Hawaii 8 transferred three hundred prisoners out of the State, and the 9 number of transfers has been rapidly rising ever since. Ten 10 years later in 2006, Hawaii had 1,844 prisoners housed in 11 private prisons on the mainland. Today, Hawaii has over two 12 thousand prisoners serving their sentences in Corrections 13 Corporation of America prisons in Arizona and Kentucky.

14 The legislature further finds that there has never been an 15 audit of the private mainland prisons that Hawaii has contracted 16 with to house the State's inmates, despite the fact that deaths

and serious injuries have occurred at several of the contract
 prisons on the mainland.

The purpose of this Act is to require performance audits of private prisons on the mainland housing Hawaii prisoners with regard to the issues of delivery of services, visitation, and the department of public safety's monitoring of those contracts.

7 SECTION 2. The office of the auditor shall conduct a
8 performance audit of the Saguaro Correctional Facility in Eloy,
9 Arizona and the Otter Creek Correctional Facility in
10 Wheelwright, Kentucky. Each performance audit shall cover:

- 11 (1) Treatment and services provided to Hawaii inmates,
- 12 including:
- 13 (A) Medical services;
- 14 (B) Mental health services;
- 15 (C) Substance abuse treatment;
- 16 (D) Education;
- 17 (E) Vocational training; and
- 18 (F) Food services;
- 19 (2) Facilitation of family and community connections,
- 20 including:
- 21 (A) Visitation;
- 22 (B) Videoconferencing; and

2	(3) The department of public safety's execution of its

8	SECTION 3. There is appropriated out of the general		
9	revenues of the State of Hawaii the sum of \$ or so

13	The sum appropriated shall be expended by the auditor for		
14	the purposes of this Act.

18	SECTION 5. This Act shall take effect on July 1, 2008;
