1	SECTION 1. Chapter 346, Hawaii Revised Statutes, is
2	amended by adding a new section to part II to be appropriately

5	Beginning July 1, 2007, the reimbursement rate for psychiatric
6	services shall be per cent of the medicare fee schedule;
7	provided that in any county with a population of 200,000 or
8	less, the reimbursement rate for psychiatric services shall be
9	per cent of the medicare fee schedule.
10	(b) Notwithstanding any law to the contrary, the
11	department shall make appropriate adjustments to the rate of
12	payment per participating recipient amount paid to health
13	maintenance organizations and prepaid health plans pursuant to
