BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 356D, Hawaii Revised Statutes, is 2 amended by adding a new section to part I to be appropriately 3 designated and to read as follows: 4 "§356D- Prohibition on smoking in and around public 5 housing; designated smoking areas. (a) Smoking shall be 6 prohibited in a public housing project, or state low-income 7 housing project as defined in section 356D-51, within: 8 Each individual housing unit; (1) 9 (2) Hallways; 10 (3) Enclosed or partially enclosed common areas; and 11 (4)Twenty feet of each building comprising the public 12 housing project. 13 (b) Notwithstanding subsection (a), the authority shall designate one or more permissible smoking areas not less than 14 15 twenty feet from any residential building or community facility. 16 (c) For purposes of this section:
