### A BILL FOR AN ACT

RELATING TO IOLANI PALACE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 6E-35, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "S6E-35 Iolani Palace. (a) The official designation of
- 4 the palace of the former monarchs of Hawaii shall be Iolani
- 5 Palace.
- 6 (b) The official designation of the Friends of Iolani
- 7 Palace shall be the State of Hawaii Museum of Monarchy History.
- 8 The qualifying standards and conditions related to the receipt
- 9 of funds under chapter 42F shall not apply to funds received by
- 10 the State of Hawaii Museum of Monarchy History; provided that if
- 11 the museum contracts with a recipient or provider, then the
- 12 qualifying standards, conditions, and other provisions of
- 13 chapter 42F shall apply to the recipient or provider and the
- 14 contract.
- 15 (c) The State of Hawaii Museum of Monarchy History shall
- 16 be licensed or accredited, in accordance with federal, state, or
- 17 county statutes, rules, or ordinances, to conduct the activities

- 1 or provide the services for which funds are appropriated; comply
- 2 with all applicable federal and state laws prohibiting
- 3 discrimination against any person on the basis of race, color,
- 4 national origin, religion, creed, sex, age, sexual orientation,
- 5 or disability; and agree not to use the funds for entertainment
- 6 or lobbying activities.
- 7 (d) The State of Hawaii Museum of Monarchy History shall
- 8 be incorporated under the laws of the State; have bylaws or
- 9 policies that describe the manner in which the activities or
- 10 services for which a grant or subsidy is awarded shall be
- 11 conducted or provided; have been determined and designated to be
- 12 a non-profit organization by the Internal Revenue Service; and
- 13 have a governing board whose members have no material conflict
- 14 of interest and serve without compensation.
- 15 [<del>(e)</del>] (e) The comptroller and state auditor shall have the
- 16 authority to examine the use of funds appropriated to the State
- 17 of Hawaii Museum of Monarchy History.
- 18 [<del>(d)</del>] (f) The State of Hawaii Museum of Monarchy History
- 19 shall provide to the legislature an annual report no later than
- 20 twenty days prior to the convening of each regular session,
- 21 which shall include an explanation of the facility maintenance
