### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 711, Hawaii Revised Statutes, is		
2	amended by	y adding two new sections to be appropriately	
3	designated and to read as follows:		
4	" <u>§71</u>	1- Harassment by disruptive threats. (1) A person	
5	commits t	he offense of harassment by disruptive threats if the	
6	person:		
7	<u>(a)</u>	Wilfully posts a message or writing through the use of	
8		any medium of communication, including an electronic	
9		communication device, with the intent to harass,	
10		annoy, intimidate, terrorize, frighten, or cause	
11		mental, emotional, or physical distress to another	
12		person, or with the intent to disrupt the orderly	
13		conduct of any institution such as a school or	
14		business; or	
15	<u>(b)</u>	Wilfully posts a message or writing through the use of	
16		any medium of communication, including an electronic	
17		communication device, and knows or should reasonably	

1	know that posting the message or writing would cause
2	another person to be frightened or to suffer mental,
3	emotional, or physical distress, or would disrupt the
4	orderly conduct of any institution such as a school or
5	business.
6	(2) For the purposes of this section:
7	"Electronic communication" shall have the same meaning as
8	provided in section 2510(12) of title 18 of the United States
9	Code.
10	"Electronic communication device" includes, but is not
11	limited to, telephones, cellular or digital mobile phones,
12	computers, video recorders, fax machines, or pagers.
13	(3) Harassment by disruptive threats is a misdemeanor and
14	shall be punishable by a fine of not more than \$2,000, or a term
15	of imprisonment not to exceed one year, or both.
16	§711- Remote harassment. (1) A person commits the
17	offense of remote harassment if the person, with the intent to
18	annoy, harass, intimidate, terrorize, or cause mental,
19	emotional, or physical distress to another person, wilfully
20	posts a writing or message of any type, including but not
21	limited to advertisements or solicitations, through the use of

14		mental, or physical distress, or to feel terrorized,
15		frightened, intimidated, threatened, harassed, or
16		annoyed; and
17	<u>(d)</u>	Conduct arising from posting the message or writing
18		caused a person to suffer emotional, mental, or
19		physical distress, or to feel terrorized, frightened,
20		intimidated, threatened, harassed, or annoyed.

### Report Title:

Crime; Harassment; Disruptive Threats

### Description:

Makes harassment by disruptive threats a misdemeanor. Makes it a crime to remotely harass another person by posting any type of writing or message with the intent to harass, intimidate, terrorize, frighten, or cause mental, emotional, or physical distress to another person.
