A BILL FOR AN ACT

RELATING TO WATER SYSTEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 168-3, Hawaii Revised Statutes, is
2	amended to read as follows:

4	all receipts and revenues received by it from the operation of

6	respective special account for that irrigation and water

8	established under section 167-22. The fund shall be used and
9	expended for the following purposes:
10	(1) Payment of the operating and maintenance costs of the
11	system; provided that payment is made only from the
12	special account created for that system in the fund;
13	(2) Repairs, replacements, additions, and extensions;
14	(3) Reimbursement to the State the amount of any principal
15	or interest due upon any bond issue under this
16	chapter."
17	SECTION 2. Section 168-5, Hawaii Revised Statutes, is

18 amended as follows:

By amending subsection (a) to read: 1 " (a) There shall be [a special account] special accounts 2 3 in the irrigation system revolving fund of the board of 4 agriculture to be known as the "irrigation systems [account".] accounts". There shall be one special account in the revolving 5 fund for each irrigation and water utilization system. 6 7 director of finance may make temporary use of any portion or all 8 of the money not immediately needed for construction and 9 operation of an irrigation system for the purpose of paying 10 warrants drawn on the treasury for current indebtedness of the 11 State, or for deposit in the state sinking fund for the repayment of bonds, or for investment in state bonds; provided 12 13 that sufficient of the sums so taken, deposited or invested shall be redeposited to the credit of the irrigation systems 14 15 account prior to the time when any engagement for the payment from the account falls due. 16 The moneys from [the] each account shall be expended upon 17 warrants drawn by the comptroller for the purposes of this 18 19 chapter." 2.
