A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 321, Hawaii Revised Statutes, is amended by adding a new part to be appropriately designated and 2 3 to read as follows: TOBACCO PRODUCTS; MINORS 4 5 §321-A Definitions. As used in this part: "Minor" means any person under the age of eighteen years. "Possession" means knowingly having direct physical control 7 at a given time or knowingly having the power and the intention, 8 at a given time, to exercise dominion or control, including the 9 10 actual use of the tobacco product.
- 11 "Tobacco product" means tobacco in any form, including
- 12 cigarettes, cigars, snuff, and chewing tobacco, that is prepared
- 13 or intended for consumption by, or the personal use of, humans.
- 14 §321-B Tobacco products; minors; possession. Possession
- 15 of a tobacco product by a minor shall be prohibited.
- 16 §321-C Exemptions. This part shall not apply to:

(a) An agent or employee of 12 the department of health or a law enforcement officer who 13 witnesses a minor in the act of violating section 321-B shall 14 issue a citation to the minor; provided that the family court 15 shall be informed as provided in section 571-21(a) for 16 appropriate proceedings under chapter 571.
- 17 (b) The department shall adopt rules under chapter 91 for
 18 the violation of this part, including the establishment of the
 19 amount of any administrative fine, community service
 20 requirements, and attendance at youth smoking education
 21 programs; provided that the parents or legal guardians of a

- 3 SECTION 2. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so

- 8 The sum appropriated shall be expended by the department of
- 9 health for the purposes of this Act.
- 10 SECTION 3. In codifying the new sections added by section
- 11 1 of this Act, the revisor of statutes shall substitute
- 12 appropriate section numbers for the letters used in designating
- 13 the new sections in this Act.
- 14 SECTION 4. This Act shall take effect upon its approval;
- 15 provided that section 2 shall take effect on July 1, 2008.
