A BILL FOR AN ACT

RELATING TO THE STATE COMMISSION ON FATHERHOOD.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Recognizing the important and unique role
- 2 fathers play in the lives of their children, families, and
- 3 communities, the legislature established the Hawaii commission
- 4 on fatherhood (commission) in 2003. Act 156, Session Laws of
- 5 Hawaii 2003, as amended by Act 148, Session Laws of Hawaii 2005,
- 6 and Act 232, Session Laws of Hawaii 2006, directs the commission
- 7 to serve in an advisory capacity to state agencies in order to
- 8 promote healthy family relationships between parents and
- 9 children. The commission is authorized to make recommendations
- 10 on programs, services, and contracts relating to children and
- 11 families. It is attached to the department of human services
- 12 for administrative purposes.
- In order to implement its strategic plan and otherwise
- 14 fulfill its responsibilities, the commission must hire an
- 15 executive director and staff. Doing so would enable the
- 16 commission to:
