BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 184-3.4, Hawaii Revised Statutes, is
 amended to read as follows:

3 "§184-3.4 State parks special fund. (a) There is
4 established within the state treasury a fund to be known as the
5 state parks special fund, into which shall be deposited:

All proceeds collected by the state parks programs 6 (1)involving park user fees, any leases or concession 7 agreements, the sale of any article purchased from the 8 department to benefit the state parks programs, or any 9 gifts or contributions; provided that proceeds derived 10 from the operation of Iolani Palace shall be used to 11 supplement its educational and interpretive programs; 12 and 13

14 (2) Transient accommodations tax revenues pursuant to
15 section 237D-6.5; provided that these moneys shall be
16 expended in response to a master plan developed in
17 coordination with the Hawaii tourism authority.
