A BILL FOR AN ACT

RELATING TO PRIMARY AND SPECIAL PRIMARY ELECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii's
- 2 constitution and election statute have encouraged voter
- 3 participation in primary elections by allowing voters to select
- 4 any political party's ballot without declaring a party
- 5 preference or nonpartisanship as a condition of voting. While
- 6 some candidates may have sought votes from members of a
- 7 different political party, public confidence in this open
- 8 primary election system continues to be high.
- 9 However, the possibility remains that a political party
- 10 could improperly affect the outcome of an opposing party's
- 11 primary election. A party could do this by encouraging its
- 12 members to cast votes for the weaker candidate of the opposing
- 13 party, thus allowing their candidate to face the weaker
- 14 candidate in the general election.
- 15 The legislature further finds that in order to ensure the
- 16 integrity of primary elections and prevent misuse of election
- 17 laws, crossover voting by members of political parties should be

- 1 prohibited. Political party members would then be allowed to
- 2 vote only in their respective party's primary election.
- 3 The purpose of this Act is to prohibit members of a
- 4 political party from participating in the primary or special
- 5 primary election of candidates from any other political party;
- 6 provided that voters who are not members of a political party
- 7 would continue to:
- 8 (1) Be issued the primary or special primary ballot for
- 9 each party and the nonpartisan primary or special
- 10 primary ballot; and
- 11 (2) Be entitled to select and to vote the ballot of any
- one party or nonpartisan.
- 13 SECTION 2. Section 12-21, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- 15 "\$12-21 Official party ballots. The primary or special
- 16 primary ballot shall be clearly designated as such. The names
- 17 of the candidates of each party qualifying under section 11-61
- 18 or 11-62 and of nonpartisan candidates [may] shall be printed on
- 19 separate ballots[, or on a single ballot. The name of each
- 20 party and the nonpartisan designation shall be distinctly
- 21 printed and sufficiently separate from each other]. The names
- 22 of [all] the candidates shall be printed on the [ballots] ballots

- 1 as provided in section 11-115. When the names of all candidates
- 2 of the same party for the same office exceed the maximum number
- 3 of voting positions on a single side of a ballot card, the
- 4 excess names may be arranged and listed on both sides of the
- 5 ballot card and additional ballot cards if necessary. [When
- 6 separate ballots for each party are not used, the order in which
- 7 parties appear on the ballot, including nonpartisan, shall be
- 8 determined by lot.]
- 9 The chief election officer or the county clerk, in the case
- 10 of county elections, shall approve printed samples or proofs of
- 11 the respective party ballots as to uniformity of size, weight,
- 12 shape, and thickness prior to final printing of the official
- 13 ballots."
- 14 SECTION 3. Section 12-31, Hawaii Revised Statutes, is
- 15 amended to read as follows:
- 16 "§12-31 Selection of party ballot; voting. [№] (a) A
- 17 person eligible to vote in any primary or special primary
- 18 election shall be required to state a party [preference or
- 19 nonpartisanship] membership or nonmembership as a condition of
- 20 voting. Each voter who is a member of a political party shall
- 21 be issued the primary or special primary ballot for that party;
- 22 provided that each voter who is not a member of a party shall be



- 1 issued the primary or special primary ballot for each party and
- 2 the nonpartisan primary or special primary ballot. A voter
- 3 shall be entitled to vote only for candidates of one party or
- 4 only for nonpartisan candidates. If the primary or special
- 5 primary ballot is marked contrary to this paragraph, the ballot
- 6 shall not be counted.
- 7 (b) In any primary or special primary election in the year
- 8 1979 and thereafter, a voter shall be entitled to select and to
- 9 vote the ballot of any one party or nonpartisan, regardless of
- 10 which ballot the voter voted in any preceding primary or special
- 11 primary election[-]; provided that the voter is in compliance
- 12 with subsection (a)."
- 13 SECTION 4. Statutory material to be repealed is bracketed
- 14 and stricken. New statutory material is underscored.
- 15 SECTION 5. This Act shall take effect upon the
- 16 ratification of a constitutional amendment to article 2,
- 17 section 4, of the Constitution of the State of Hawaii, which
- 18 requires a voter to declare membership or nonmembership in a
- 19 political party as a condition of voting in any primary or
- 20 special primary election.
