A BILL FOR AN ACT

RELATING TO PETROLEUM INDUSTRY REPORTING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 486J-1, Hawaii Revised Statutes, is
- 2 amended by adding four new definitions to be appropriately
- 3 inserted and to read as follows:
- 4 ""Bulk sales" means the wholesale sale of gasoline in
- 5 individual transactions which exceed the size of a truckload.
- 6 "Crude oil cost" refers generally to the cost of raw
- 7 material necessary for processing by a refinery into products.
- 8 "Dealer tank wagon" means the wholesale sale of gasoline
- 9 priced on a delivered basis to a retail outlet.
- 10 "Rack sales" means wholesale truckload sales or smaller of
- 11 gasoline where title transfers at a terminal."
- 12 SECTION 2. Section 486J-4.5, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- "§486J-4.5 Informational cost reports[-]; publication.
- 15 (a) Each refiner, on a semi-annual basis, at reporting dates as
- 16 the commission may establish, shall file with the commission, on
- 17 forms prescribed, prepared, and furnished by the commission, a

- 1 certified statement of operating and overhead costs for the
- 2 refiner's Hawaii operations that shall include but not be
- 3 limited to the following:
- 4 (1) Crude oil costs and sources;
- 5 (2) Other feedstock costs and sources;
- 6 (3) Refinery operating expenses;
- 7 (4) Marketing operating expenses by petroleum product;
- **8** (5) Distribution expenses by petroleum product; and
- 9 (6) Corporate overhead expenses.
- 10 (b) In addition to the reporting required under subsection
- 11 (a), each distributor shall file with the commission all
- 12 Securities and Exchange Commission Forms 10-K, 10-Q, annual
- 13 reports, quarterly reports, and earnings supplements published
- 14 by the distributor.
- 15 (c) Each distributor, except a distributor who is so
- 16 defined solely by criteria in paragraph (4) of that definition
- 17 in section 486J-1, who sells liquid fuel only at retail and is
- 18 not a refiner, shall file with the commission, on a semi-annual
- 19 basis at reporting dates as the commission may establish, on
- 20 forms prescribed, prepared, and furnished by the commission, a
- 21 certified statement of operating and overhead costs that shall
- 22 include the following:

- 1 SECTION 3. If any provision of this Act, or the
- 2 application thereof to any person or circumstance is held
- 3 invalid or is suspended by a court of competent jurisdiction,
- 4 the invalidity or suspension shall not affect other provisions
- 5 or applications of the Act, which can be given effect without
- 6 the invalid or suspended provision or application, and to this
- 7 end the provisions of this Act are severable.
- 8 SECTION 4. Statutory material to be repealed is bracketed
- 9 and stricken. New statutory material is underscored.
- 10 SECTION 5. This Act shall take effect on July 1, 2050.
