BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 302A, Hawaii Revised Statutes, is

- 4 "§302A- Department of education real property and
- 5 facilities use revolving fund. (a) There is established the
- 6 department of education real property and facilities use
- 7 revolving fund into which shall be deposited all revenues
- 8 collected by the department for the use of department real
- 9 property and facilities, except as otherwise provided by law.
- 10 The board may establish prices, fees, and charges, including
- 11 those for sale, lease, or use of department real property and
- 12 facilities, which include land, buildings, grounds, furnishing,
- 13 and equipment; provided that the department shall comply with
- 14 all statutory and common law requirements in the disposition of
- 15 ceded lands. The board shall be exempt from the public notice
- 16 and public hearing requirements of chapter 91 in establishing
- 17 and amending the fees and charges. The department may establish
