A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that, in 2002, the board
2	of education approved the establishment of school complex areas,
3	comprised of two or more school complexes, with each complex
4	consisting of one high school and the intermediate or middle and
5	elementary schools that feed into it. The legislature further
6	finds that the complex areas are headed by complex area
7	superintendents to allow for school administration closer to its
8	own constituencies. The legislature believes that the
9	establishment of complex areas provides the opportunity for the
10	more efficient management of schools and school complexes
11	contained therein. The allocation of resources within a complex
12	area could also prove highly cost-effective. More autonomy in
13	the management of complex areas can yield beneficial results for
14	the students, staff, and administrators. For these reasons,
15	greater discretion for the allocation of resources should lie

with the complex area superintendents.

         SECTION 2. There is appropriated out of the general

2		limited to participation in Harvard Change Leadership
3		programs;
4	(2)	Teacher induction mentoring;
5	(3)	Academic coaches for school programs including but not
6		limited to robotics, speech and debate, and science
7		clubs; provided that the department of education shall
8		establish and provide funding at three different
9		levels, based upon the total number of students
10		participating in the club or activity and the total
11		number of hands-on hours the coach spends with the
12		students;
13	(4)	Programs or initiatives for professional development
14		for teachers; and
15	(5)	Programs or initiatives to increase teacher retention.
16	The	sum appropriated shall be expended by the department of
17	education	for the purposes of this Act.
