A BILL FOR AN ACT

RELATING TO COMPTROLLER SUPERVISION OF ACCOUNTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 40-1, Hawaii Revised Statutes, is 1 amended by amending subsection (b) to read as follows: 2 "(b) With respect to the executive branch, except the 3 University of Hawaii until June 30, 2011, the Hawaii tourism 4 authority, and the department of education until June 30, 2011, 5 the comptroller shall have complete supervision of all accounts. 6 The comptroller shall preaudit all proposed payments of \$10,000 7 or more to determine the propriety of expenditures and 8 compliance with executive orders and rules that may be in 9 effect. When necessary, the comptroller shall withhold approval 10 of any payment. Whenever approval is withheld, the department 11 or agency concerned shall be promptly notified. With respect to 12 the University of Hawaii, the Hawaii tourism authority, and the 13 department of education, the comptroller shall issue warrants 14 15 for the release of funds for the operating costs of the university, the Hawaii tourism authority, or the department of 16 education, as applicable, in amounts and at times mutually 17 agreed upon by the governor or director of finance and the 18
