## A BILL FOR AN ACT

RELATING TO HA'IKU VALLEY.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

The legislature finds that Ha'iku valley on Oahu SECTION 1. 3 is of significant cultural and historic importance to the native people of Hawai'i. Ha'iku valley is renowned for its 4 5 archaeological and other cultural and historic sites, including lo'i, sacred sites, and burial sites, and for the presence of 6 7 native and endangered flora and fauna. Preserving the valley's 8 cultural and historic resources and educating the public about 9 these resources are of paramount importance. 10 The legislature further finds that ownership of the valley 11 is segmented among several entities. The valley's segmented 12 ownership and limited stewardship have placed its cultural and 13 historic resources at high risk. Adequate management of the 14 valley, and appropriate access to the valley, have proven 15 elusive. 16 The purpose of this Act is to establish the Ha'iku valley 17 cultural preserve commission, which shall have policy and management oversight of the Ha'iku valley cultural preserve. 18 The

- 1 establishment of the commission will provide a system that
- 2 recognizes the valley's unique challenges and preserves in
- 3 perpetuity its cultural and historic resources for the people of
- 4 Hawai'i.
- 5 SECTION 2. The Hawaii Revised Statutes is amended by
- 6 adding a new chapter to be appropriately designated and to read
- 7 as follows:
- 8 "CHAPTER
- 9 HA'IKU VALLEY CULTURAL PRESERVE
- 10 § -1 Administration of chapter. The Ha'iku valley
- 11 cultural preserve commission and the office of Hawaiian affairs
- 12 shall administer this chapter.
- 13 § -2 Definitions. As used in this chapter, unless the
- 14 context otherwise requires:
- 15 "Commission" means the Ha'iku valley cultural preserve
- 16 commission.
- "Department" means the department of land and natural
- 18 resources.
- 19 "Office" means the office of Hawaiian affairs.
- 20 "Valley cultural preserve" means the area designated as
- 21 Ha'iku valley.

- 9 (b) The chairperson shall be elected from among the 10 members of the commission, by the members of the commission.
- 11 (c) The members of the commission shall serve without pay
  12 but shall be reimbursed for their actual and necessary expenses,
  13 including travel expenses, incurred in carrying out their
  14 duties.
- (d) Any action taken by the commission shall be approvedby a simple majority of its members. Four members shallconstitute a quorum to do business.
- (e) The commission, without regard to the requirements of chapter 76, may hire employees necessary to perform its duties.
- 20 § -6 Responsibilities and duties of the commission. The 21 general administration of the valley cultural preserve shall

3	(1)	Shall establish criteria, policies, and controls for

9		matter relating to the valley cultural preserve;

11		department of the attorney general on any matter

13		office;
14	(5)	May enter into curator or stewardship agreements with
15		appropriate Hawaiian cultural and spiritual community
16		organizations for the perpetuation of native Hawaiian
17		cultural, religious, and subsistence customs, beliefs,
18		and practices for the purposes stated in section -3;
19	(6)	Shall carry out those powers and duties otherwise
20		conferred upon the board of land and natural resources
21		and the land use commission with regard to
22		dispositions and approvals pertaining to the valley

1 chapter as the commission deems reasonable and proper 2 for the effective administration of this chapter; and May solicit and accept grants, donations, and 3 (11)contributions for deposit into the Ha'iku valley 4 5 cultural preserve trust fund to support the purposes of this chapter. 6 Farming. Section -3 notwithstanding, the 8 commission shall adopt rules pursuant to chapter 91 to permit farming activities in the valley cultural preserve that are 9 10 consistent with the purpose of this chapter and that take into consideration the health and safety of the general public. 11 12 -8 Penalty. Any person who violates any of the laws or rules applicable to the valley cultural preserve shall be 13 14 quilty of a petty misdemeanor and shall be fined not more than \$1,000 or imprisoned not more than thirty days, or both, for 15 16 each offense. Each day of each violation shall be deemed a separate offense. 17 18 -9 General administrative penalties. (a) Except as 19 otherwise provided by law, the commission is authorized to set, 20 charge, and collect administrative fines, or bring legal action 21 to recover administrative costs of the commission or the 22 department, or payment for damages, or for the cost to correct

- 1 damages resulting from a violation of this chapter or any rule
- 2 adopted hereunder. The administrative fines shall be as
- 3 follows:
- 4 (1) For a first violation, a fine of not more than \$10,000;
- (2) For a second violation within five years of a previous
   violation, by a fine of not more than \$15,000; and
- 8 (3) For a third or subsequent violation within five years
  9 of the last violation, by a fine of not more than
  10 \$25,000.
- 11 (b) In addition, an administrative fine of up to \$5,000
- 12 may be levied for each specimen of natural resource or any
- 13 historic property taken, killed, injured, broken, or damaged in
- 14 violation of any rule adopted under this chapter. For purposes
- 15 of this section, "natural resource" includes any archaeological
- 16 artifacts, minerals, any aquatic life or wildlife or parts
- 17 thereof, including their eggs, and any land plants or parts
- 18 thereof, including seeds. Also for purposes of this section,
- 19 "historic property" means any building, structure, object,
- 20 districts, landscapes, area, or site, including heiau and
- 21 underwater sites, that is over fifty years old.

- (c) Any criminal penalty for any violation of this chapter
   or any rule adopted under this chapter shall not be deemed to
- 3 preclude the commission from bringing a civil legal action to
- 4 recover additional administrative fines and costs. Any civil
- 5 legal action against a person to recover administrative fines
- 6 and costs for any violation of this chapter or any rule adopted
- 7 under this chapter shall not be deemed the State from pursuing
- 8 any criminal action against that person.
- 9 (d) In any judicial proceeding to recover an
- 10 administrative penalty imposed, the commission need only show
- 11 that notice was given, that a hearing was held or the time
- 12 granted for requesting a hearing has run without such a request,
- 13 that an administrative penalty was imposed, and the
- 14 administrative penalty remains unpaid.
- 15 § -10 Administrative violation system. With the mutual
- 16 consent of both the commission and the department, the
- 17 commission may use the civil natural resource violations system
- 18 of the department of land and natural resources; provided that
- 19 the commission shall act whenever the board is authorized to
- 20 act, to process violations of this chapter or any rules adopted
- 21 hereunder.

1 § -11 Transfer. Upon its conveyance to the office, the 2 resources and waters of the valley cultural preserve shall be 3 held in trust by the office as part of the public land trust; provided that the office shall transfer management and control 4 5 of the valley cultural preserve to the sovereign native Hawaiian entity upon its recognition by the United States and the State. 6 All terms, conditions, agreements, and laws affecting the 8 valley shall remain in effect unless expressly terminated. 9 -12 Ha'iku valley cultural preserve trust fund. (a) There is created in the state treasury a trust fund to be 10 designated as the Ha'iku valley cultural preserve trust fund to 11 12 be administered by the office with the prior approval of the commission. Subject to this chapter: 13 All moneys received from the federal government for 14 (1)purposes consistent with this chapter; 15 16 (2) Any moneys appropriated by the legislature to the trust fund; 17 Any moneys received from grants, donations, or the 18 (3) 19 proceeds from contributions; and The interest or return on investments earned from 20 (4)

moneys in the trust fund;

- 1 shall be deposited in the trust fund and shall be used to
- 2 fulfill the purposes of this chapter.
- 3 (b) The commission may use moneys in the trust fund to
- 4 carry out the purposes of this chapter, including hiring
- 5 employees, specialists, and consultants necessary to complete
- 6 projects related to the purposes of this chapter.
- 7 (c) Moneys deposited into or appropriated to the trust
- 8 fund shall remain available until they are obligated or until
- 9 the trust fund is terminated.
- 10 (d) If the trust fund is terminated, all funds shall be
- 11 transferred to the general fund; provided that all unexpended or
- 12 unencumbered balances shall be disbursed in accordance with any
- 13 requirements set by funding sources and for purposes consistent
- 14 with this chapter.
- 15 (e) The commission shall submit an annual report on the
- 16 status of the Ha'iku valley cultural preserve trust fund to the
- 17 legislature, no later than twenty days prior to the convening of
- 18 each regular session of the legislature. The annual report
- 19 shall include the total number of and amount of grants,
- 20 donations, and contributions received and balances remaining on
- 21 June 30 of each year.
