## A BILL FOR AN ACT

RELATING TO PROCUREMENT.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the state
- 2 procurement policy office, in order to fully discharge its
- 3 responsibilities, must take further steps to ensure compliance
- 4 with chapter 103D, Hawaii Revised Statutes, by the executive
- 5 agencies.
- 6 The legislature further finds that the comptroller should
- 7 be an ex-officio non-voting member of the state procurement
- 8 policy board in order to ensure the board's independence.
- 9 The purpose of this Act is to require the procurement
- 10 policy office to conduct compliance audits, and to make the
- 11 comptroller an ex-officio non-voting member of the procurement
- 12 policy board.
- 13 SECTION 2. Section 103D-201, Hawaii Revised Statutes, is
- 14 amended by amending subsection (b) to read as follows:
- 15 "(b) The state procurement policy board shall consist of
- 16 seven members. Notwithstanding the limitations of section 78-4,
- 17 the members of the board shall include:

1 (1)The comptroller[+] as an ex-officio nonvoting member; 2 (2) A county employee with significant high-level procurement experience; and 3 (3) Five persons who shall not otherwise be full-time 5 employees of the State or any county; provided that at least one member shall be a certified professional in 6 7 the field of procurement, at least one member shall have significant high-level, federal procurement 8 9 experience, and at least two members shall have significant experience in the field of health and 10 11 human services. Each appointed member shall have demonstrated sufficient 12 13 business or professional experience to discharge the functions 14 of the state procurement policy board. The initial and subsequent members of the state procurement policy board, other 15 than the comptroller, shall be appointed by the governor from a 16 17 list of three individuals for each vacant position, submitted by 18 a nominating committee composed of four individuals chosen as 19 follows: two persons appointed by the governor; one person appointed by the president of the senate; and one person 20 appointed by the speaker of the house. - 1 policy board members shall be subject to the requirements of
- 2 section 26-34. No member of the state procurement policy board
- 3 shall act concurrently as a chief procurement officer. The
- 4 members of the state procurement policy board shall devote such
- 5 time to their duties as may be necessary for the proper
- 6 discharge thereof."
- 7 SECTION 3. Section 103D-202, Hawaii Revised Statutes, is
- 8 amended to read as follows:
- 9 "\$103D-202 Authority and duties of the policy board. (a)
- 10 Except as otherwise provided in this chapter, the state
- 11 procurement policy board shall have the authority and
- 12 responsibility to adopt rules, consistent with this chapter,
- 13 governing the procurement, management, control, and disposal of
- 14 any and all goods, services, and construction. All rules shall
- 15 be adopted in accordance with chapter 91; provided that the
- 16 policy board shall have the power to issue interim rules by
- 17 procurement directives, which shall be exempt from the public
- 18 notice, public hearing, and gubernatorial approval requirements
- 19 of chapter 91. The interim rules shall be effective for not
- 20 more than eighteen months.
