Description:

Requires that the electronic posting of contracts awards of \$5,000 or more for the procurement of professional services also include the ranking of the persons selected; requires the purchasing agency to notify in writing all offerors that solicited an award of their non-selection not later than the day of the posting of the award, including specified information; increases the time for protesting an award from five to seven days of its posting.
