### A BILL FOR AN ACT

RELATING TO SCIENCE AND TECHNOLOGY INITIATIVES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Hawaii Academy 2 of Science is a private, not-for-profit education organization
- 3 that has administered and operated the Hawaii state science and
- 4 engineering fair for more than fifty years, producing a
- 5 successful, innovative, and popular interscholastic education
- 6 program for public school and private school secondary students.
- 7 The legislature further finds that the programs currently
- 8 operated or proposed by the Hawaii Academy of Science employ the
- 9 concepts of experiential learning and encourage innovative
- 10 methodologies that engage students in project-based
- 11 problem-solving. These methodologies are an important strategy
- 12 to prepare the next generation of Hawaii's youth for the global
- 13 economy.
- 14 The legislature also finds that state funding appropriated
- 15 to the department of education to assist the Hawaii Academy of
- 16 Science in the administration and operation of the Hawaii state
- 17 science and engineering fair has not always been sufficient to

- 1 cover the full costs of operating the Hawaii state science and
- 2 engineering fair. These moneys were used to fund salaries and
- 3 benefits for the staff of the Hawaii Academy of Science, and to
- 4 assist in procuring the rental of the fair's venue and necessary
- 5 equipment for the operation of the Hawaii state science and
- 6 engineering fair, and other attendant costs. Annual funding was
- 7 allocated by the department to the research corporation of the
- 8 University of Hawaii to serve as expending agency for the Hawaii
- 9 Academy of Science since 1990. In recent years, the funding
- 10 allocated has not been sufficient to cover the operation of the
- 11 Hawaii Academy of Science's interscholastic academic programs.
- 12 The legislature recognizes the inherent value of
- 13 interscholastic academic programs provided by private
- 14 not-for-profit organizations such as the Hawaii Academy of
- 15 Science, and restored state funding to the Hawaii state science
- 16 and engineering fair in 2007.
- 17 The purpose of this Act is to appropriate moneys to the
- 18 department of education to provide the necessary financial
- 19 assistance to the Hawaii Academy of Science:
- 20 (1) For the administration and operation of all current
- and future interscholastic academic programs; and

1	(2) To increase that organization's capacity and reach to
2	the greater community, through the development of
3	teacher training and outreach workshops and programs,
4	student internships, workshops, seminars, and other
5	learning opportunities to allow for the effective
6	mentoring, counseling, and guidance of students who
7	display an interest in science, technology and
8	engineering.
9	SECTION 2. Act 213, Session Laws of Hawaii 2007, is
10	amended by amending section 70 to read as follows:
11	"SECTION 70. Provided that of the general fund
12	appropriation for school-based budgeting (EDN 100), the sum of
13	\$250,000 or so much thereof as may be necessary for fiscal year
14	2007-2008 and the sum of \$250,000 or so much thereof as may be
15	necessary for fiscal year 2008-2009 shall be expended by the
16	department of education for the [engineering and science fair;]
17	Hawaii Academy of Science, to assist the organization in the
18	administration and operations of all its current and future
19	interscholastic academic programs, including outreach and
20	training programs; and provided further that any unexpended
21	funds shall lapse to the general fund."

- 1 SECTION 3. Session law material to be repealed is
- 2 bracketed and stricken. New session law material is
- 3 underscored.
- 4 SECTION 4. This Act shall take effect on July 1, 2008.
