## A BILL FOR AN ACT

RELATING TO AGRICULTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 The legislature finds that organic farming SECTION 1. 2 practices are beneficial to human health and the preservation of 3 environmental quality because these practices emphasize sustainability, enhance soil health, and promote the practice of 4 5 growing agricultural products without the use of toxic 6 substances, such as pesticides and fertilizers. While organic 7 farming is an important building block for maintaining and preserving the State's scenic and environmental resources, it is 8 9 also an essential element in creating economic viability and 10 preserving the quality of life in rural and agricultural 11 communities. The Organic Foods Production Act (7 U.S.C. chapter 94) 12 13 establishes national standards governing the marketing of certain agricultural products as organically produced products;
- certain agricultural products as organically produced products
  assures consumers that organically produced products meet a
  consistent standard; and facilitates interstate commerce in
  fresh and processed food that is organically produced. The

- 1 federal regulations under the National Organic Program (7 C.F.R.
- 2 part 205) provide that each state may implement an organic
- 3 program for agricultural products that have been produced and
- 4 handled within the state, using organic methods that meet the
- 5 requirements of the Organic Foods Production Act and the
- 6 National Organic Program. Due to the sensitive nature of
- 7 Hawaii's environment and the unique challenges that Hawaii
- 8 organic farmers face, it is necessary to develop a state organic
- 9 program pursuant to the National Organic Program, develop and
- 10 implement a state organic plan, and conduct oversight of all
- 11 organic agricultural activities statewide.
- 12 According to a national study, approximately two per cent
- 13 of the United States food supply is grown using organic methods
- 14 and the nationwide retail sales of organic food and beverages in
- 15 2005 totaled approximately \$12,800,000,000. Currently, there
- 16 are close to two hundred farms in Hawaii, which produce organic
- 17 products, such as coffee, macadamia nuts, bananas, pineapples,
- 18 ginger, mangos, citrus fruits, avocados, tomatoes, and salad
- 19 greens. The Hawaii Organic Farmers Association, an accredited
- 20 third party certification agency for the United States
- 21 Department of Agriculture's National Organic Program, estimates

- 1 that organic farming in Hawaii is a \$5,000,000 to \$10,000,000
- per year industry.
- 3 There is currently a high and increasing demand for organic
- 4 produce that exceeds Hawaii's local supply. In order to meet
- 5 this demand, local produce markets and large mainland chain
- 6 stores must import organic produce from the mainland and other
- 7 countries. The importation of organic produce can result in a
- 8 higher number of invasive species inadvertently brought into the
- 9 State, and can impact the State's agricultural sector, economy,
- 10 and sustainable food supply.
- 11 The purpose of this Act is to:
- 12 (1) Establish a state organic program under the direction
- of the department of agriculture;
- 14 (2) Require the department of agriculture to develop and
- implement a plan for the state organic program; and
- 16 (3) Appropriate funds to the department of agriculture to
- 17 establish and implement this program.
- 18 SECTION 2. Chapter 141, Hawaii Revised Statutes, is
- 19 amended by adding a new section to be appropriately designated
- 20 and to read as follows:
- 21 "\$141- State organic program. (a) There is established
- 22 within the department of agriculture a state organic program,

13		by federal, state, county, and private agencies in

15		promote and support worthwhile organic agriculture
16		activities;
17	(5)	Serve as an information clearinghouse for organic
18		agriculture activities;
19	(6)	Actively seek federal funding for organic agriculture
20		activities;
21	(7)	Undertake activities required to develop and expand
22		the organic agriculture industry;

17	and responsibilities of the state organic program by			
18	November	30, 2008. The department of agriculture shall		
19	implement	the detailed plan for the state organic program no	,	
20	later than	n June 30, 2009.		
21	SECT	TION 4. There is appropriated out of the general		
22	revenues	of the State of Hawaii the sum of \$ or so

- 1 much thereof as may be necessary for fiscal year 2008-2009 for
- 2 the department of agriculture to establish and implement an
- 3 organic agriculture program.
- 4 The sum appropriated shall be expended by the department of
- 5 agriculture for the purposes of this Act.
- 6 SECTION 5. New statutory material is underscored.
- 7 SECTION 6. This Act shall take effect upon its approval;
- 8 provided that section 4 shall take effect on July 1, 2008.
