A BILL FOR AN ACT

RELATING TO PHOTOVOLTAIC SYSTEMS FOR PAY AS YOU SAVE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Act 240, Session Laws of Hawaii 2006, is amended
by amending section 13 to read as follows:

"SECTION 13. Solar [water heating] pay as you save program; 3 purpose; establishment; tariff filing. (a) Solar water heating 4 systems are a renewable energy technology that uses solar 5 collectors placed on roofs to heat water. [These] Photovoltaic 6 systems use solar collectors to generate electricity. Solar 7 water heating systems decrease reliance on imported oil used to 8 generate electricity to heat water because they use less energy 9 10 than the electric hot water heating systems replaced. Photovoltaic systems also decrease reliance on imported oil by 11

12 generating electricity on site for residential use.

The legislature finds that the up-front cost of installation is a barrier preventing many Hawaii residents from installing solar water heating systems[-] and photovoltaic systems. The legislature further finds that the renewable energy technologies income tax credit and electric utility rebates have not been enough of an incentive to overcome these up-front costs,

JUSTIFICATION SHEET

DEPARTMENT: Business, Economic Development, and Tourism

TITLE: A BILL FOR AN ACT RELATING TO PHOTOVOLTAIC SYSTEMS FOR PAY AS YOU SAVE.

PURPOSE: Expands the successful "Pay As You Save" solar water heater program to photovoltaic systems that convert sunshine into electricity, allowing users to pay each month through their electricity bill.

MEANS: Amend Section 13 of Act 240, Session Laws of Hawaii 2006.

JUSTIFICATION: Photovoltaic systems use the sun to generate electricity for direct use by the home owner. With the rising cost of electricity, photovoltaic systems, using the Pay as You Save program, will allow home owners to purchase and install photovoltaic systems to reduce their monthly utility bills by amortizing payments on a monthly basis. As with solar water heating, the upfront costs can be prohibitive for home owners. With Pay as You Save, these costs can be spread over time and make photovoltaic systems accessible to home owners. Photovoltaic systems are an off-the-shelf and readily available technology that uses solar energy to reduce the State's dependence on fossil fuel.

> Impact on the public: Since this proposal will not require a home owner to pay the full upfront cost to purchase and install a residential photovoltaic system, we anticipate that the proposal will be an attractive option to participants. By spreading the cost over time to purchase and install photovoltaic systems, we anticipate that more systems will be installed. It is difficult to estimate the number of participants for such a program.
