## A BILL FOR AN ACT

RELATING TO CRIMINAL HISTORY BACKGROUND CHECKS FOR SOCIAL SERVICES PROGRAMS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 346-17, Hawaii Revised Statutes, is 2 amended as follows: 3 By amending subsection (f) to read: 4 "(f) As a condition for a certificate of approval, any organization, institution, or foster boarding home, including 5 6 all adults residing in the foster boarding home, shall: 7 (1) Meet all standards and requirements established by the 8 department; 9 Be subject to criminal history record checks in (2) 10 accordance with section 846-2.7, and child abuse and 11 neglect registry checks, in accordance with 12 departmental procedures; and
- 13 (3) Provide consent to the department or its designee to
  14 obtain criminal history record and child abuse and
  15 neglect registry information.
- 16 New employees of the organization, institution, or home shall be
- 17 fingerprinted within five working days of employment."

13	first two years that an individual identified in subsection (b)
14	is required to have such checks, and shall conduct a criminal
15	history record name inquiry into the state criminal history
16	records annually or biennially thereafter."
17	SECTION 4. Section 346-154, Hawaii Revised Statutes, is

### Report Title:

Criminal History Background Checks; Social Services Programs

### Description:

Authorizes the department of human services or its designee to conduct criminal history record checks for those providing services to vulnerable adults and children. (CD1)
