## A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE HAWAII HEALTH SYSTEMS CORPORATION.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. This emergency appropriation is necessary to
- 5 ensure that the Hawaii health systems corporation can pay for
- 6 operation and provision of current levels of service at Leahi
- 7 Hospital, Maluhia, Samuel Mahelona Memorial Hospital, Lana'i
- 8 Community Hospital, Hilo Medical Center, Ka'u Hospital, Kona
- 9 Community Hospital, and Kohala Hospital.
- 10 The purpose of this Act is to appropriate \$14,000,000 in
- 11 general funds for fiscal year 2007-2008 to adjust accounts
- 12 payable remittances to no more than forty-five days from the
- 13 date of the invoice for Hawaii health systems corporation's
- 14 facilities in order to bring current accounts payable balances
- 15 that are due to essential vendors. This will allow delivery of
- 16 goods and services to these facilities to continue on a timely

- 1 basis so that the facilities will be able to maintain
- 2 operations.
- 3 SECTION 3. (a) There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$14,000,000, or so
- 5 much thereof as may be necessary, for fiscal year 2007-2008 to
- 6 be used by the Hawaii health systems corporation to pay accounts
- 7 payable within forty-five days from the date of the invoice for
- 8 Hawaii health systems corporation's facilities; provided that
- 9 the operating loan that is being negotiated by Maui memorial
- 10 medical center closes prior to the enactment of this Act.
- 11 (b) If the operating loan being negotiated by Maui
- 12 memorial medical center does not close prior to enactment of
- 13 this Act, there is appropriated out of the general revenues of
- 14 the State of Hawaii the sum of \$11,000,000, or so much thereof
- 15 as may be necessary, in addition to the \$14,000,000 or so much
- 16 thereof as may be necessary that is appropriated in subsection
- 17 (a), for fiscal year 2007-2008 to be used by the Hawaii health
- 18 systems corporation to pay accounts payable within forty-five
- 19 days from the date of the invoice for Hawaii health systems
- 20 corporation's facilities, including the Maui memorial medical
- 21 center located in the Maui region of the Hawaii health systems
- 22 corporation.

- 1 (c) The sum appropriated shall be expended by the Hawaii
- 2 health systems corporation for the purposes of this Act.
- 3 SECTION 4. This Act shall take effect upon its approval.
