- 9 territory or possession under the jurisdiction of the
- 10 United States and are qualified as determined by the
- 11 board through rules adopted pursuant to chapter 91; or
- 12 (2) Graduated from a registered nursing program at an
- educational institution in a foreign jurisdiction, and
- have had their transcripts evaluated by professional
- 15 evaluators designated by the board and are considered
- 16 qualified as determined by the board through rules
- adopted pursuant to chapter 91[+]; or
