A BILL FOR AN ACT

RELATING TO ORGANIC AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Organic farming practices are beneficial to 2 human health and towards the preservation of environmental 3 quality because these practices emphasize sustainability, 4 enhance soil health, and promote the practice of growing 5 agricultural products without the use of toxic substances, such 6 as pesticides and fertilizers. While organic farming is an 7 important building block for maintaining and preserving the 8 State's scenic and environmental resources, it is also an 9 essential element in creating economic viability and preserving 10 the quality of life in rural and agricultural communities. 11 According to a national study, approximately two per cent of the United States food supply is grown using organic methods 12 and the nationwide retail sales of organic food and beverages in 13 14 2005 totaled approximately \$12,800,000,000. There are over 15 ninety organic farms in Hawaii, which produce organic products 16 such as coffee, macadamia nuts, bananas, pineapples, ginger,

mangoes, citrus fruits, avocados, tomatoes, and salad greens.

- 1 The Hawaii Organic Farmers Association, an accredited third
- 2 party certification agency for the United States Department of
- 3 Agriculture's National Organic Program, estimates that organic
- 4 farming in Hawaii is a \$5,000,000 to \$10,000,000 per year
- 5 industry.
- 6 There is currently a high and increasing demand for organic
- 7 produce that exceeds the State's local organic food supply, and
- 8 to meet this demand, local produce markets and large mainland
- 9 chain stores must import organic produce from the mainland and
- 10 other countries. The importation of organic produce can result
- 11 in a higher number of invasive species that are inadvertently
- 12 brought into the State upon arrival, and can impact the State's
- 13 agriculture sector, economy, and sustainable food supply.
- 14 The purpose of this Act is to establish an organic
- 15 agriculture task force under the direction of the department of
- 16 business, economic development, and tourism to focus on the
- 17 promotion of organic agriculture as a key industry for the
- 18 State, and to appropriate funds to the task force to carry out
- 19 its purposes.
- 20 SECTION 2. (a) There is established within the department
- 21 of business, economic development, and tourism an organic

5	(c)	The organic agriculture task force shall:
6	(1)	Examine the current status, activities, policies,
7		directives, and programs relating to the promotion and
8		development of organic agriculture in the State;
9	(2)	Identify impediments to developing and promoting
10		organic agriculture in the State;
11	(3)	Review other jurisdictions' activities, policies,
12		directives, and programs related to the promotion and
13		development of organic agriculture as a key industry;
14	(4)	Explore any other options available to the task force
15		to promote and develop organic agriculture as a key
16		economic industry for the State; and
17	(5)	Establish findings and recommendations on how the
18		State may best develop and promote organic agriculture
19		as a key industry.
20	(d)	The members of the organic agriculture task force
21	chall col	out the chairmorgon of the tack force and chall be

- 1 reimbursed for expenses, including travel expenses, necessary
- 2 for the performance of their duties.
- 3 (e) The organic agriculture task force shall submit its
- 4 findings and recommendations to the legislature, including any
- 5 proposed legislation, no later than twenty days prior to the
- 6 convening of the 2009 regular session.
- 7 (f) The department of business, economic development, and
- 8 tourism shall provide support services necessary to assist the
- 9 task force in achieving its purposes as required under this Act.
- 10 SECTION 3. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$ or so
- 12 much thereof as may be necessary for fiscal year 2008-2009 for
- 13 the organic agriculture task force to carry out its purposes,
- 14 including research and support services and reimbursement of
- 15 expenses for task force members.
- 16 The sum appropriated shall be expended by the department of
- 17 business, economic development, and tourism for the purposes of
- 18 this Act.
- 19 SECTION 4. This Act shall take effect upon its approval;
- 20 provided that section 3 shall take effect on July 1, 2008.
