A BILL FOR AN ACT

RELATING TO TEACHER HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature is aware that with an overall
- 2 shortage of teachers and other school staff members, including
- 3 administrators and related service professionals, many schools
- 4 are hard-pressed to keep staff from accepting positions in other
- 5 schools or leaving the profession altogether. The cost and
- 6 availability of housing can greatly impact the recruitment and
- 7 retention of teachers, especially in geographically isolated
- 8 communities and in schools that are plagued with hard-to-fill
- 9 vacancies. In addition, the high cost of housing in Hawaii
- 10 creates added economic stress on younger teachers who are most
- 11 likely to leave the profession.
- 12 The legislature is also aware that the current condition of
- 13 state-owned teacher housing mandates that units undergo
- 14 extensive repair and renovation, and will require a consistent
- 15 maintenance program and dedicated oversight and support
- 16 personnel when the program is transferred from the Hawaii

- 1 housing finance and development corporation to the department of
- 2 education.
- 3 The purpose of this Act is to address the teacher shortage
- 4 problem in Hawaii by creating a program that offers housing to
- 5 teachers at affordable costs.
- 6 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
- 7 amended by adding three new sections to part III, subpart E, to
- 8 be appropriately designated and to read as follows:
- 9 "§302A-A Educators' affordable housing program. (a)
- 10 There is established an affordable housing program for qualified
- 11 teachers and other employees of the department under this
- 12 subpart to be administered by the department.
- 13 (b) The department shall offer a deferred-interest second
- 14 mortgage to qualified teachers and staff (and their spouses if
- 15 the property will be owned jointly) at the time they purchase a
- 16 residential dwelling unit. The deferred-interest second
- 17 mortgage is due, together with deferred interest, at the earlier
- 18 of:
- 19 (1) The sale of the property;
- 20 (2) Other conveyance of the property;
- 21 (3) Six months after the purchaser ceases to be qualified;

- 7 year 2008-2009, to the department of education for management of
- 8 the teacher housing program and to bring existing units to

- 10 SECTION 7. The sums appropriated shall be expended by the

- 13 2, 4, and 5 of this Act, the revisor of statutes shall
- 14 substitute appropriate section numbers for the letters used in
- 15 designating the new sections in this Act.

- 18 SECTION 10. This Act shall take effect on July 1, 2007.

Description:

Provides for a report on the effectiveness of housing availability in increasing teacher recruitment.
